Objectives and Investment Policy

The Fund belongs to the category of money market funds («MMF») as defined by Regulation (EU) 2017/1131 of the European Parliament and of the Council of 14 June 2017 on money market funds (the «Regulation»). It seeks to achieve the best possible return in USD in line with prevailing money market rates, over a 3-month period while aiming to preserve capital consistent with such rates and to maintain a high degree of liquidity and diversification; the 3-month period corresponds to the recommended investment horizon of the sub-fund.

The Fund is a standard variable net asset value MMF as defined by the Regulation.

It invests within the limits of the Regulation in a diversified portfolio of USD denominated money market instruments, deposits with credit institutions, repurchase agreements and reverse repurchase agreements, units or shares of short term MMF or other standard MMF, and ancillary liquid assets denominated in USD. Financial derivative instruments (e.g. Interest Rate Swaps) are used only for the purpose of hedging the interest rate of the Fund. The impact of these financial

derivative instruments will be taken into account for the calculation of the Weighted Average Maturity.

The Fund is not a guaranteed product. There is no currency exposure, other than to the USD.

It is actively managed against the Cash Index USD LIBID 3 Months (RI).

The investment team applies also BNP PARIBAS ASSET MANAGEMENT Sustainable Investment Policy, which takes into account Environmental, Social and Governance (ESG) criteria in the investments of the Fund.

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).




Charges
