INDONESIA MARKET WRAP

EQUITY MARKET

SLIGHT REBOUND

JCI was traded lower during the opening session before rebounded and closed at intraday high 4,532 (+66 points or +1.47%) today. Shares across regional markets were mixed with oil surged after China unveiled plans to boost its reserves. Meanwhile, foreign investors recorded net outflow of IDR 384Bn today and rupiah slightly weakened to IDR 16,495/USD.

Banking stocks were mixed as BMRI (+3.04%), BBNI (+4.62%), and BNLI (+4.95%) closed higher, while BBRI (-2.05%) and BBKA (-1.28%) corrected. Consumer names advanced as HMSP (+8.48%), GGRM (+9.8%), KLBF (+10.3%), INDF (+7.09%), and UNVR (+1.05%) all rose. Material stocks were positive as TPIA (+9.05%) and BRPT (+11.41%) both up. Similar trend also happened to telco names with TLKM (+0.97%), EXCL (+5.13%), and ISAT (+11.94%) all in green. Other movers were INCO (+8.87%), AMRT (+5.3%), POLL (-6.9%), and SRTG (-6.67%).

Indonesia's inflation in Mar 2020 reached 0.1% MoM and 2.96% YoY. Cumulatively, 3M20 inflation is at 0.76% YoY. The main contributors to the inflation are gold, egg and sugar.

BOND MARKET

LOWER

Local currency received some more pressure and spot opened at 16,850/17,000 level. As eyes glued to the currency movement the bond market started the day with 10Y FR82 got given at 91.75 (8.19%). Although trading was mainly done in the interbank, the overall market tone was offerish across the board with focus was heard on the middle tenor. Although the selling pressure did not sustain, market was completely quiet in the second session. Total foreign ownership down to IDR 926.774tn on Apr 01st 2020, from previously IDR 992.072tn on March 16th 2020.

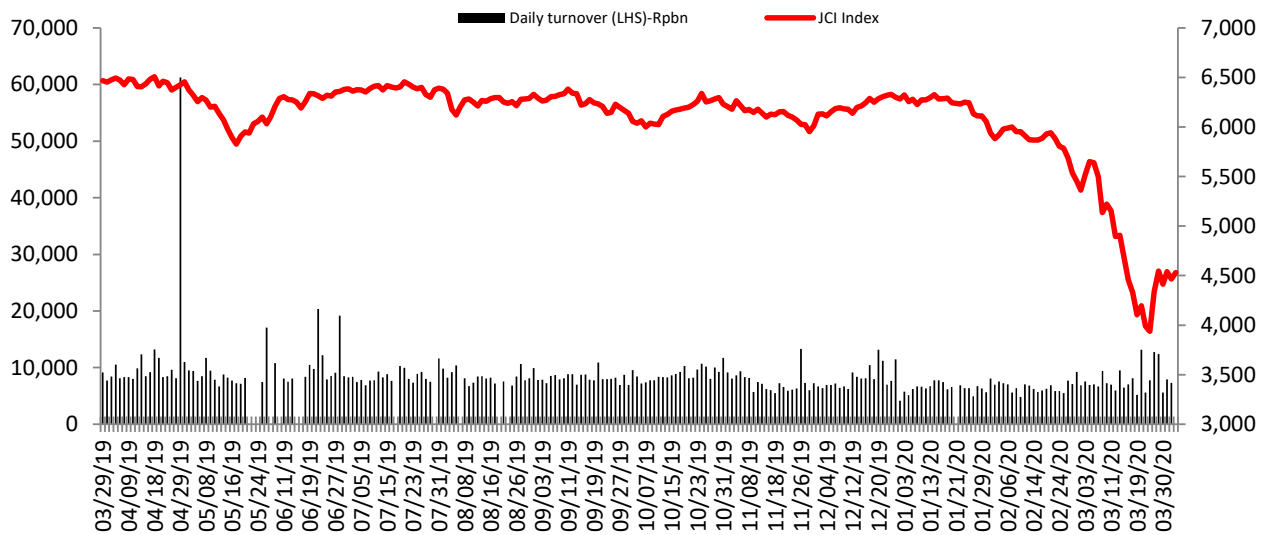

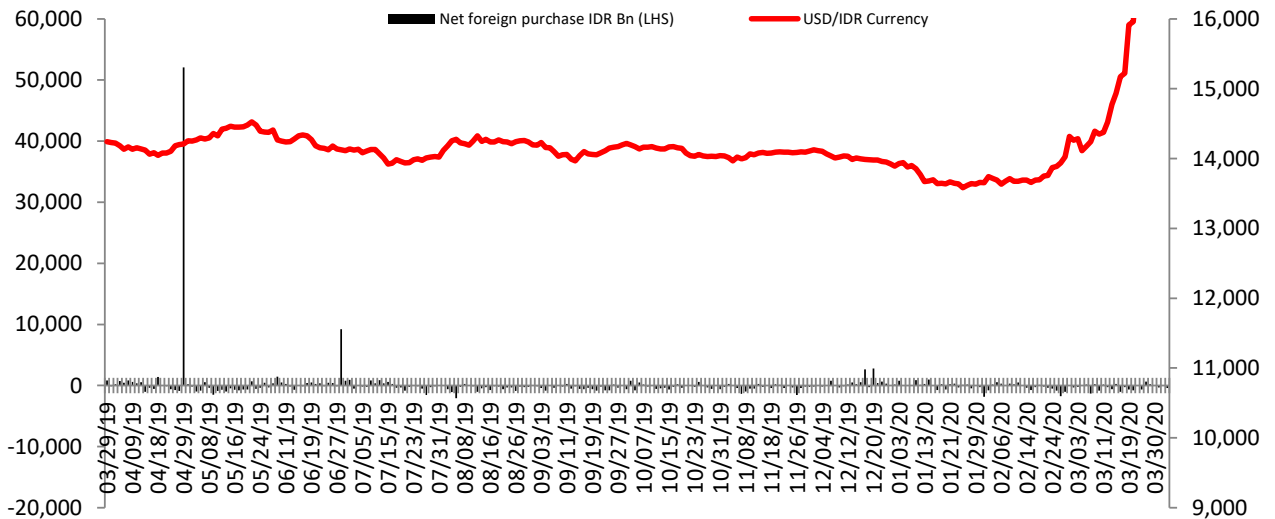
