INDONESIA MARKET WRAP

EQUITY MARKET

FLAT

JCI was flat and closed at 6,040 (-4 points or -0.07%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net inflow of IDR 132Bn today and rupiah slightly weakened to IDR 14,525/USD.

Banking stocks were mixed as BMRI (+2.61%), BBRI (+1.31%), and BDMN (+5.12%) rose, while PNB (-3.13%) and BBCA (-0.82%) down. Consumer names were mostly negative as GGRM (-0.67%), HMSP (-0.43%), KLBF (-2.21%), and UNVR (-1.42%) all down, except ICBP (+0.3%). Poultry stocks were negative as MAIN (-1.4%), JPFA (-3.78%), and CPIN (-4.48%) all declined. Retailer names were negative as LPPF (-3.2%), AMRT (-0.37%), ERAA (-2.34%), and MAPI (-3.7%) all retreated. Other movers were AGRS (+20.54%), POLL (+17.95%), SMMA (-4.09%), and MEDC (-4%).

The Indonesian government has acknowledged that the country's gross domestic product (GDP) growth will likely fall below the initial target of 4.5 to 5.3 percent for this year following the enactment of emergency public activity restrictions (PPKM Darurat).

BOND MARKET

LITTLE CHANGE

IDR bond market opened the day with prices quoted unchanged post FOMC meeting last night. Nothing much happened in the bond market today. Limited activities were seen on 10Y tenor bucket and the newly issued series while the other part of the yield curve was quoted within range throughout the day. From our side we only heard trade done in 10Y FR87 and 11Y FR91 which was last traded at 100 (6.49%) and 98.95 (6.51%). Total foreign ownership went down to IDR 972.58Tn on Jul 5 2021, from previously IDR 977.31Tn on Jun 30 2021.

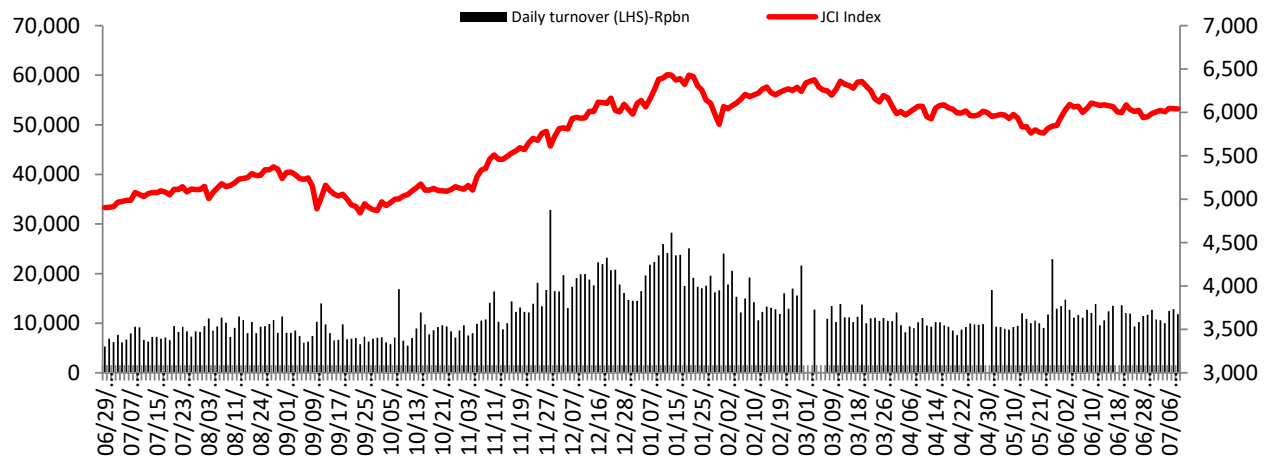

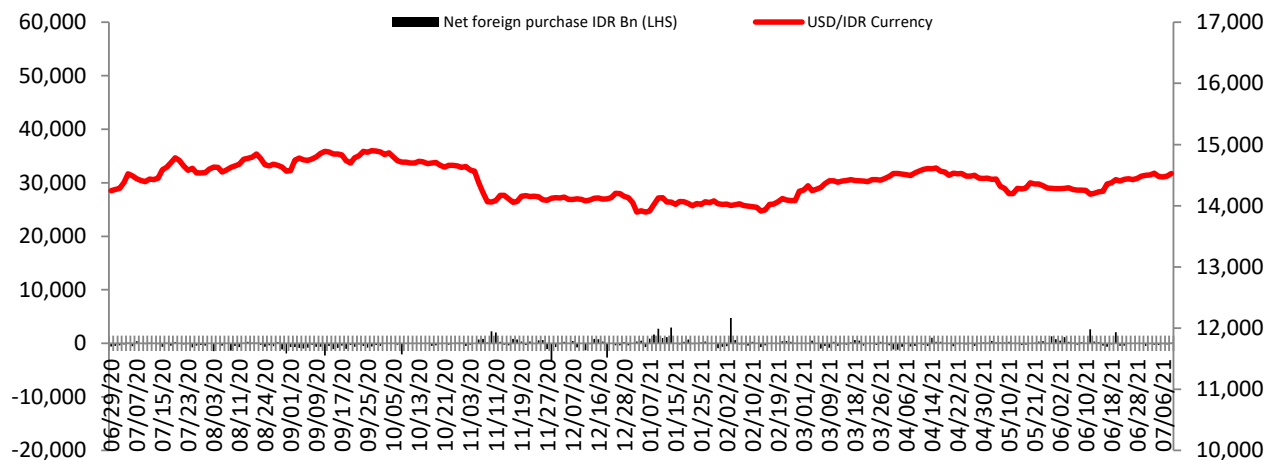
