# **EQUITY MARKET**

### REBOUNDED

JCI advanced and closed at 6,047 (+48 points or +0.8%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 229Bn today and rupiah was stabilized at IDR 14,255/USD.

Banking stocks were positive as BBCA (+1.56%), BMRI (+2.5%), MEGA (+5.36%), BBRI (+0.48%), and BBNI (+1.81%) all closed higher. Consumer names were negative as MYOR (-0.78%), KLBF (-0.69%), INDF (-1.57%), HMSP (-2.83%), and UNVR (-3.2%) all down. Mining stocks were positive as ANTM (+4.68%), INCO (+4.35%), TINS (+4.52%), PTBA (+1.37%), and ADRO (+0.41%) all advanced. Material names were positive as TPIA (+4.87%) and BRPT (+0.58%) all rose. Other movers were BHIT (+34.91%), AMRT (+14.95%), KPIG (-6.47%), and INPP (-6.08%).









