# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

#### **SLIDE DOWN**

JCI slightly weakened and closed at 5,810 (-12 points or -0.21%) today. Shares across regional markets were mostly positive after crude oil extended gains to a nine-month high following an OPEC+ deal. Meanwhile, foreign investors recorded net outflow of IDR 84Bn today and rupiah slightly strengthened to IDR 14,105/USD.

Banking stocks were mixed as PNBN (+7.58%) and BMRI (+0.38%) up, while BDMN (-0.29%), BBCA (-1.08%), and BBRI (-2.27%) down. Consumer names were mixed as UNVR (+0.66%), MYOR (+1.61%), and KLBF (+1.1%) in green, while ICBP (-0.75%) and HMSP (-1.2%) closed lower. Properties stocks were negative as BSDE (-1.4%), SMRA (-3.61%), PWON (-1.87%), and LPKR (-3.39%) all retreated. Pulp & paper names were positive as TKIM (+9.55%) and INKP (+1.87%) all jumped higher. Other movers were ADRO (+4.36%), EMTK (+4.12%), SMAR (-5.75%), and MIKA (-3.93%).

According to Deal Street Asia report, Grab Holdings and Gojek have agreed in principle to merge their operations and currently ironing out the fine print. Currently Grab valuation is estimated reach US\$14Bn while Gojek around US\$10Bn.

### **BOND MARKET**


#### **SLIGHTLY HIGHER**

Indonesia bond market closed the week with lower yield around 2-5 bps. Good sentiment boosted by currency appreciation soon triggered buying that started in the 10Y series and above. The sentiment quickly lifted prices across the board as solid bid from onshore and offshore players. Next week on December 08th , MoF will hold the last regular Sukuk auction of 6M SPNS, 3Y PBS-027, 4Y PBS-026, 5Y PBS-017 and 26Y PBS-028 with indicative target of IDR 6Tn only.


