# DAILY REPORT INDONESIA MARKET WRAP

#### **EQUITY MARKET**

#### **Slighly Lower**

JCI slightly weakened and closed at 7,309 (-13 points or -0.18%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR -1.1Tn today and rupiah was stabilized at IDR 15,775/USD.

Banking stocks were mostly positive as BBRI (+1.78%), BMRI (+0.78%), MEGA (+2.07%), and BBNI (+0.61%) all advanced, except PNBN (-3.53%). Consumer names were mixed as MYOR (-1.16%), UNVR (-1.37%), and INDF (-1.59%) weakened, while HMSP and ICBP unchanged. Properties stocks were negative as LPKR (-3.31%), BSDE (-1.91%), PWON (-2.24%), and CTRA (-3.02%) all corrected. Material names were negative as BRPT (-1.66%) and TPIA (-2.84%) all down. Other movers were MLPT (+19.91%), ARTO (+4.07%), DSNG (-17.88%), and BRMS (-6.38%).

Indo Oct-24 consumer confidence index fell to 121.1, the lowest since Dec-22, mainly due to declines in the current income, durable goods purchase, and job availability indices.

### **BOND MARKET**


#### Selling pressure

Indonesia bond market opened the day with another selling seen in 10Y tenor area following higher UST yield movement. The 10Y FR103 were traded to as low as 97.90 (7.03%) before bottom fisher came into the market. The selling pressure halted and yields went back to yesterday closing level. The market were more muted in afternoon session with no significant trade seen. The benchmark series of 5-10-15-20Y closed the day at mid yield of 6.65%, 6.90%, 7.01%, and 7.04% respectively, higher by 1-6bps compared to yesterday's closing. All eyes are now on US CPI data tonight.


