INDONESIA MARKET WRAP

EQUITY MARKET

Rebound

JCI advanced and closed at 6,901 (+36 points or +0.52%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 593Bn today and rupiah slightly weakened to IDR 16,230/USD.

Banking stocks were mixed as BBRI (+0.82%) and PNB (+0.87%) closed higher, while MEGA (-0.61%), BNL (-2.21%), and BBCA (-0.29%) closed lower. Consumer names were mostly negative as HMSP (-0.81%), GGRM (-4.83%), KLBF (-0.99%), and ICBP (-1.41%) all closed lower, except UNVR (+0.97%). Retailer stocks were mostly positive as AMRT (+3%), MAPA (+6.16%), and MAPI (+0.81%) all closed higher, except ACES (-0.41%). Material names were mixed as BRPT (+7.1%) rose, while TPIA (-0.26%) closed lower. Other movers were FILM (+12.53%), RAJA (+10.48%), YULE (-6.03%), and DNET (-4.36%).

Danantara secured an investment commitment from ACWA Power, a green hydrogen company based in Saudi Arabia. The investment collaboration worth US\$10bn is aimed at developing major projects in the green energy sector.

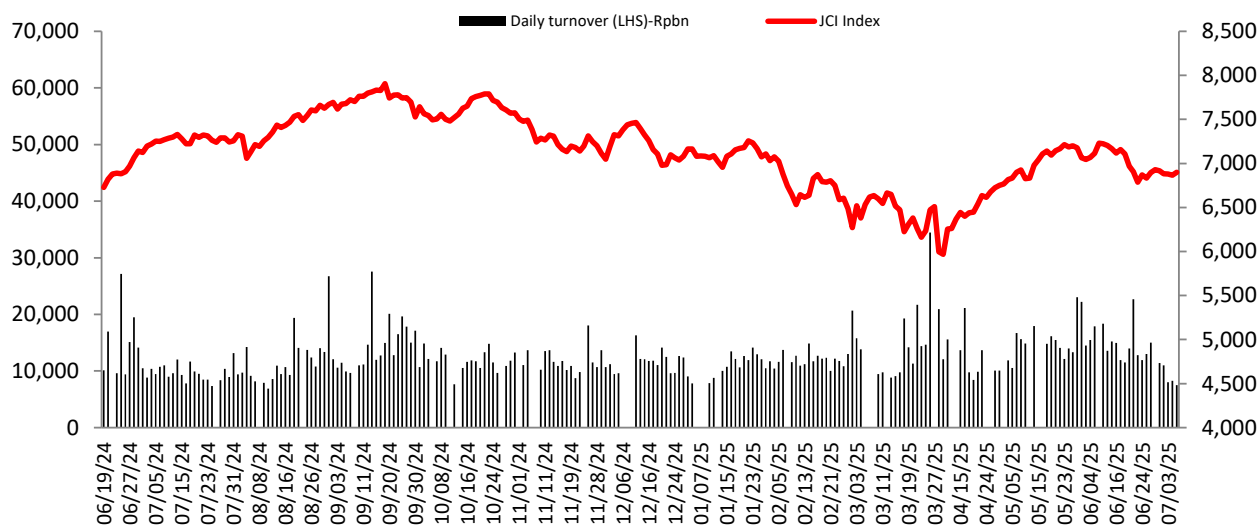

MIXED TONE

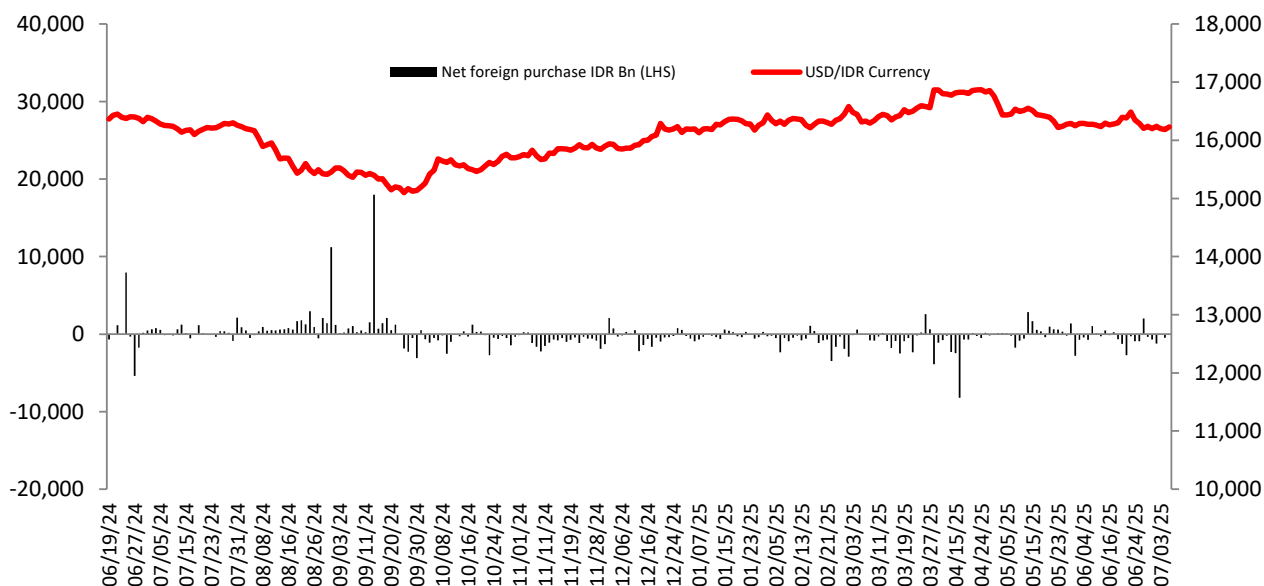
Indonesia bond market opened the day with wide spread. In the morning session, we still seen local investors and local banks collecting middle to long tenor non benchmark series in small clip. Unfortunately, the support did not sustain as profit takers came in to the market. Profit taking activities from offshore real money names until market closed. The yield curve closed flattish compared to last Friday closing with benchmark series of 5Y/10Y/15Y/20Y closed at mid yield 6.2%/6.57%/6.88%/6.96% with local currency closed at 16,240 today. There will be fresh supply tomorrow as Indonesia Debt Management Office ("DMO") will hold sukuk bond auction with issuance target at IDR 9Tn (up from 8T previously).
