## INDONESIA MARKET WRAP

---

### EQUITY MARKET

#### ANOTHER CORRECTION

JCI weakened and closed at 4,481 (-145 points or -3.14%) today. Shares across regional markets were mixed after American retail sales and factory output posted historic declines in Mar 2020. Meanwhile, foreign investors recorded net outflow of IDR -1.2Tn or the highest since 9th Mar today and rupiah slightly weakened to IDR 15,640/USD.

Banking stocks were sold-off as BDMN (-3.24%), BBNI (-5.24%), BMRI (-4.32%), BBRI (-5.43%), and BBCA (-4.47%) all closed lower. Consumer names were negative as INDF (-5.84%), ICBP (-2.7%), GGRM (-6.57%), HMSP (-3.11%), and UNVR (-4.66%) all corrected. Telco stocks were negative as FREN (-5.32%), EXCL (-4.93%), and TLKM (-3.54%) all weakened. Similar trend also happened for cement names as SMBR (-2.72%), SMCB (-4.49%), SMGR (-6.67%), and INTP (-6.93%) all in red. Other movers were MFMI (+24.43%), KREN (+19.35%), POLL (-6.96%), and UNTR (-6.21%).

Indonesia Statistics Agency (BPS) announced trade surplus of US\$743mn in March with export fell 0.2% YoY while at the same time import declined -0.75% YoY.

### BOND MARKET

#### OFFERISH

Indonesia bond market painted a different story today. Local currency received some more pressure and leveling at 15,650/15,825. Bond market received offerish tone from offshore players which put pressure on prices hence lifted yield up 8-10 bps, focus was heard on the short to middle tenor. While in the afternoon session, the market saw less trading. Yield curve closed higher with mid-yield 5Y/10Y/15Y/20Y at 7.43%/7.87%/8.08%/8.12%.

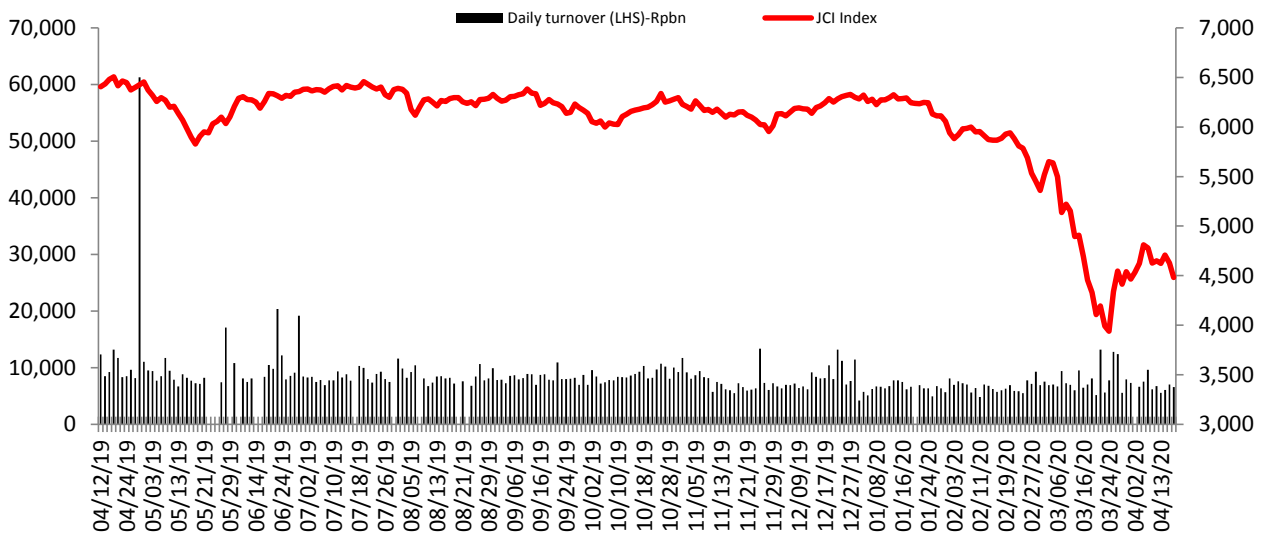

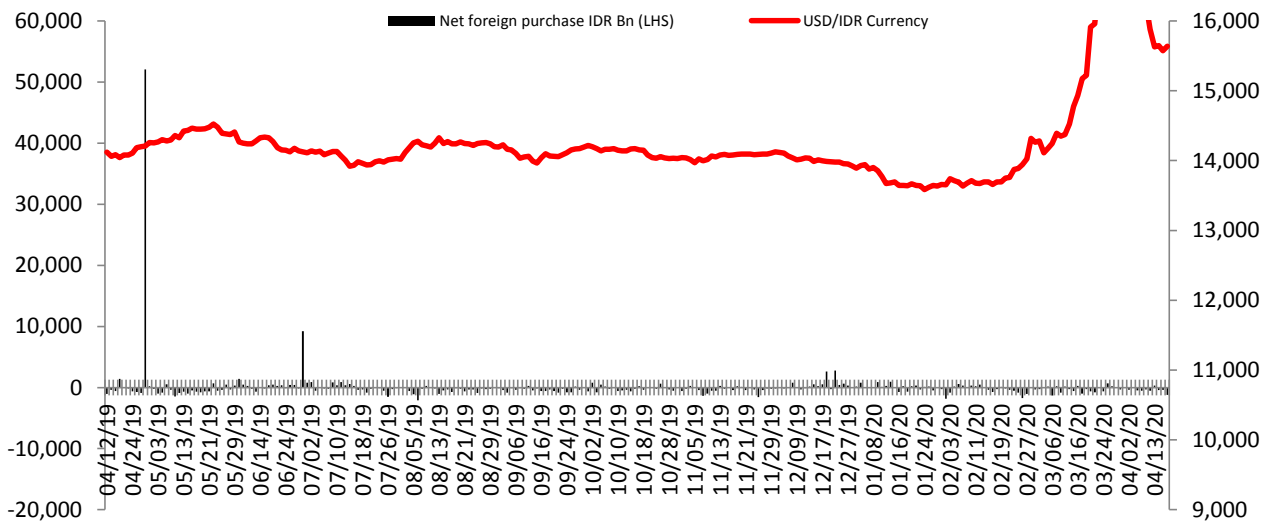
