INDONESIA MARKET WRAP

EQUITY MARKET

Slightly Lower

JCI slightly weakened and closed at 6,799 (-12 points or -0.18%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 1.82tn today and rupiah was stabilized at IDR 14,880/USD.

Banking stocks were mostly positive as BBRI (+1.02%), BBKA (+0.85%), BMRI (+0.98%), and PNBK (+3.52%) all inched higher, except BBNI (-0.27%). Consumer names were negative as HMSP (-1.93%), GGRM (-2.68%), INDF (-1.18%), ICBP (-1.47%), and KLBF (-1.45%) all corrected. Construction stocks were positive as WIKA (+6.69%), PTPP (+5.41%), ADHI (+4.12%), and WSKT (+2.94%) all rose. Mining names were mostly negative as INCO (-1.15%), PTBA (-1.51%), ITMG (-6.97%), and ADRO (-2.95%) all corrected, except INDY (+1.2%). Other movers were NFCX (+18.42%), MREI (+14.56%), ESSA (-6.99%), and BBHI (-5.65%).

The final draft of the revision Government Regulation (PP) 1/2019 concerning export proceeds from exploitation, management and processing of natural resources (PP DHE) is currently in the hands of President Joko Widodo. This regulation is targeted to take effect on July 1, 2023.

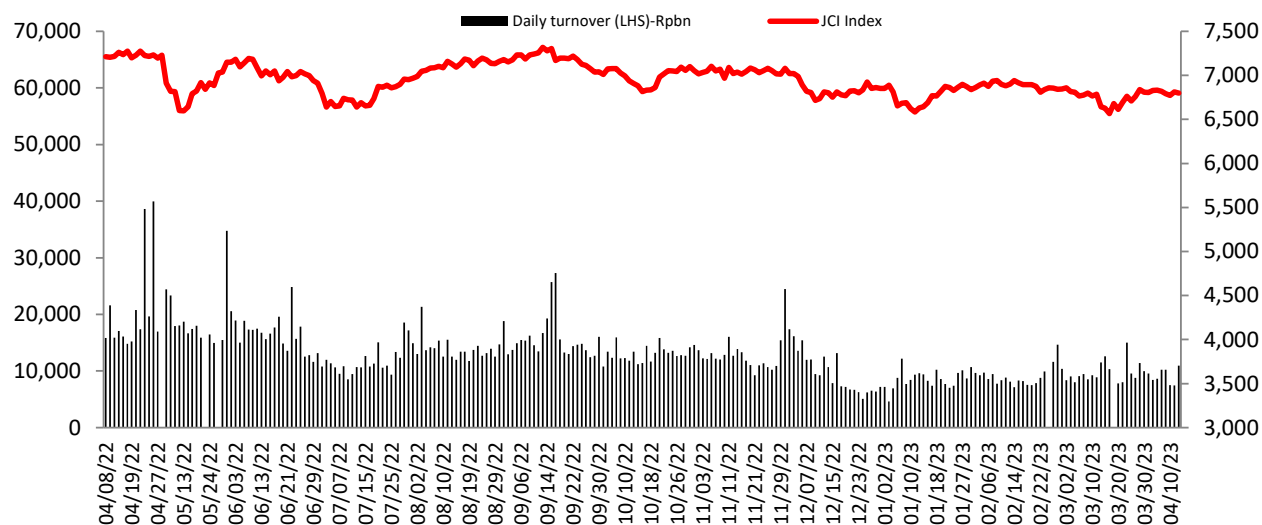

LACKLUSTER TRADING

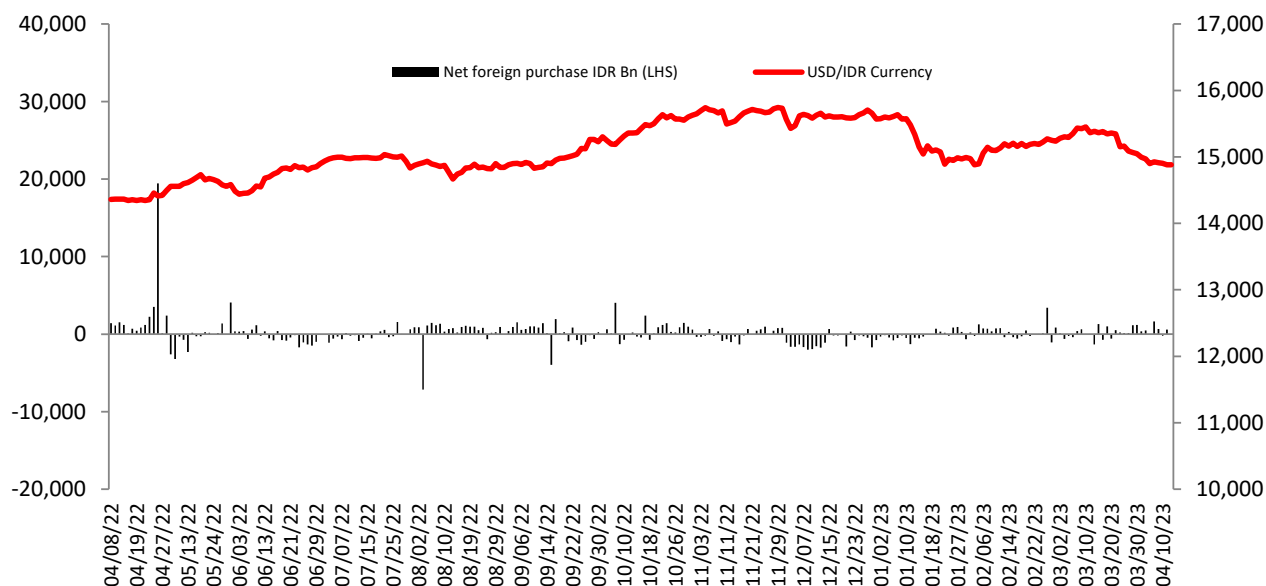
