DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

BEARISH

JCI weakened and closed at 5,979 (-130 points or -2.12%) today, its 6th consecutive day of decline. Shares across regional markets were negative. Meanwhile, foreign investors recorded net inflow of IDR 52Bn today and rupiah slightly weakened to IDR 14,078/USD.

Banking stocks were mostly negative as BDMN (-2.71%), BBNI (-3.35%), BMRI (-3.42%), and BBRI (-3.25%) all declined, except BBCA (+1.62%). Consumer names were negative as ICBP (-1.58%), UNVR (-0.7%), INDF (-3.44%), GGRM (-2.75%), and HMSP (-3.91%) all corrected. Telco stocks were negative as FREN (-6.67%), ISAT (-5.91%), and TLKM (-4.14%) all weakened. Mining names were negative as TINS (-6.92%), PTBA (-3.36%), ADRO (-3.61%), INCO (-6.09%), and ANTM (-6.67%) all closed lower. Other movers were KOTA (+10.86%), SONA (+10.7%), INTP (-6.83%), and BRPT (-6.53%).

Gov't plans to impose tax for sugary and soda drinks this year. Ministry of Finance suggested that tax will be at Rp1.2k-Rp1.5k per liter. According to simulation from tax office, Rp6.25tn of potential tax may be received by assuming 3,746mn liter sales per year. The tax enactment may lower consumption to 3,436mn liter in the first year, or equals to 8%.


THIN SUPPORT

Indonesia bond market start the day with biddish tone. Several buying interest from mixed players was seen mostly in morning session. The 5Y and 10Y benchmarks series remained as market's favorite. However, some profit taking action was seen nearing lunch time and pushed the price back to the morning level especially on 10Y benchmark series. Meanwhile from our end, we saw no trades in the afternoon session. Yield curved closed with lower $2-5\mathrm{bps}$.


