INDONESIA MARKET WRAP

EQUITY MARKET

HOLDING UP

JCI advanced and closed at 6,435 (+40 points or +0.62%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 993Bn today and rupiah slightly strengthened to IDR 14,060/USD.

Banking stocks were mixed as BBRI (+1.48%), MEGA (+1.76%), and BBNI (+0.38%) closed higher, while BMRI (-0.36%) and BBCA (-0.56%) down. Consumer names were mostly negative as ICBP (-1.06%), KAEF (-6.81%), UNVR (-1.06%), and KLBF (-6.85%) all down, except GGRM (+2.35%). Mining stocks were positive as ANTM (+12.64%), PTBA (+6.29%), INCO (+2.7%), ADRO (+2.71%), and TINS (+6.65%) all rose. Pulp & paper names were positive as INKP (+9.59%) and TKIM (+5.96%) all closed higher. Other movers were FREN (+10.61%), TBIG (+4.02%), LPKR (-4.35%), and BSDE (-3.37%).

CAUTIOUS TRADING

Indonesia bond market opened slightly higher following lower UST and weaker USD. In the morning session, mixed tone was seen specially on 10Y – 15Y area. However, there was no significant price movement in the market. Overall tone remains cautious and the yield closed the day lower by around 3 – 5 bps. On the other hand, MoF held a Green Shoe Option from yesterday Sukuk Auction. The incoming bids was IDR 4.921Tn and MoF absorbed IDR 4.7Tn.

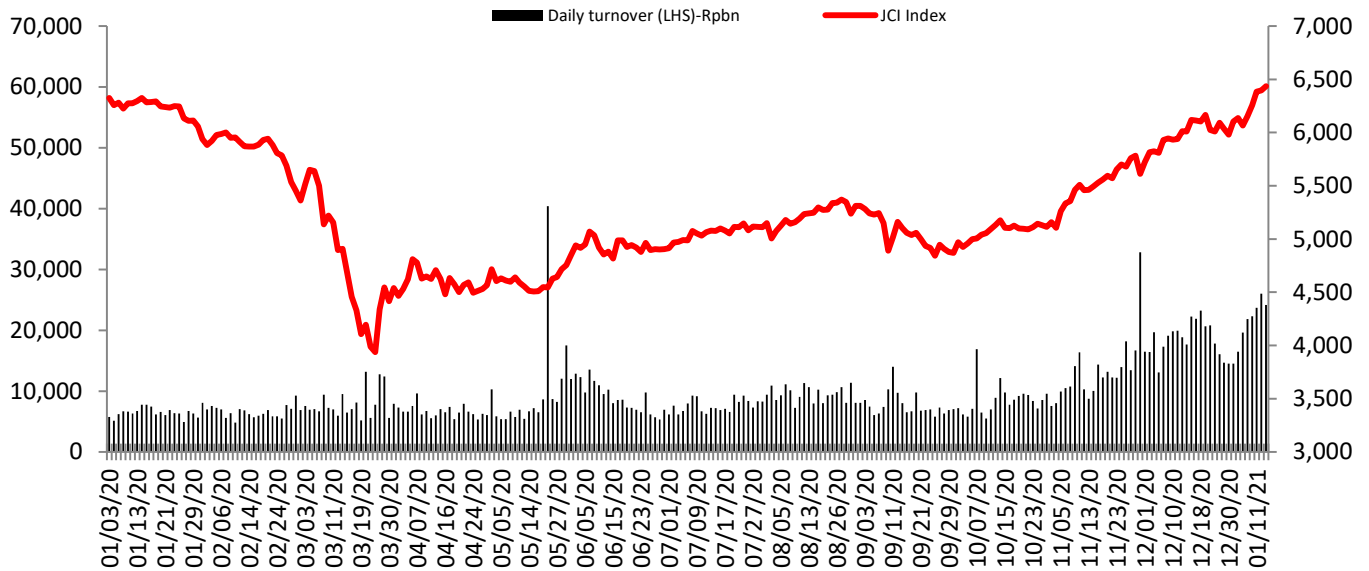

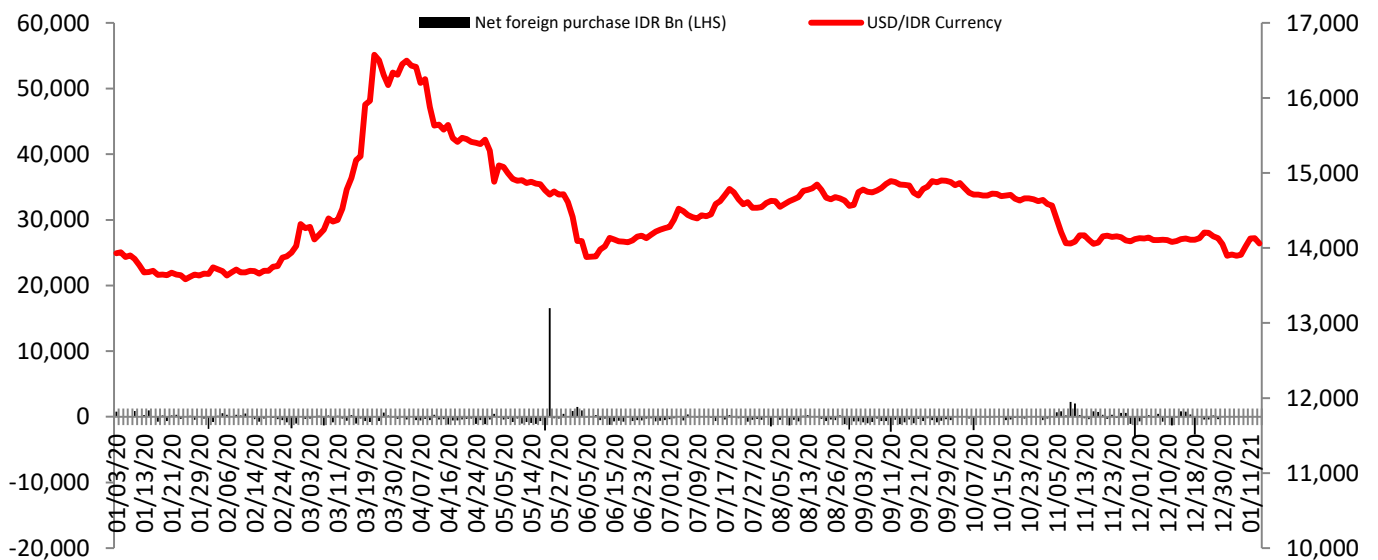
