INDONESIA MARKET WRAP

EQUITY MARKET

Continued Lower

JCI weakened and closed at 6,271 (-215 points or -3.31%) today. Shares across regional markets were negative. Meanwhile, foreign investors recorded net outflow of IDR - 2.9Tn today and rupiah weakened to IDR 16,580/USD.

Banking stocks were negative as BBTN (-6.7%), BMRI (-1.29%), BBCA (-1.17%), BBNI (-7.14%), and BBRI (-7.44%) all retreated. Consumer names were negative as HMSP (-3.64%), SIDO (-5.93%), UNVR (-15.42%), KLBF (-5.26%), and INDF (-6.25%) all retreated. Telco stocks were negative as EXCL (-1.34%), ISAT (-6.62%), and TLKM (-5.62%) all weakened. Material names were negative as BRPT (-1.88%) and TPIA (-11.26%) all weakened. Other movers were FMII (+24.83%), HITS (+24.66%), INKP (-15.7%), and BRMS (-7.81%).

The government includes the establishment plan for the National Revenue Agency and increasing the national revenue ratio to GDP to 23% as one of the national priorities in the 2024-2029 National Medium-Term Development Plan (RPJMN).

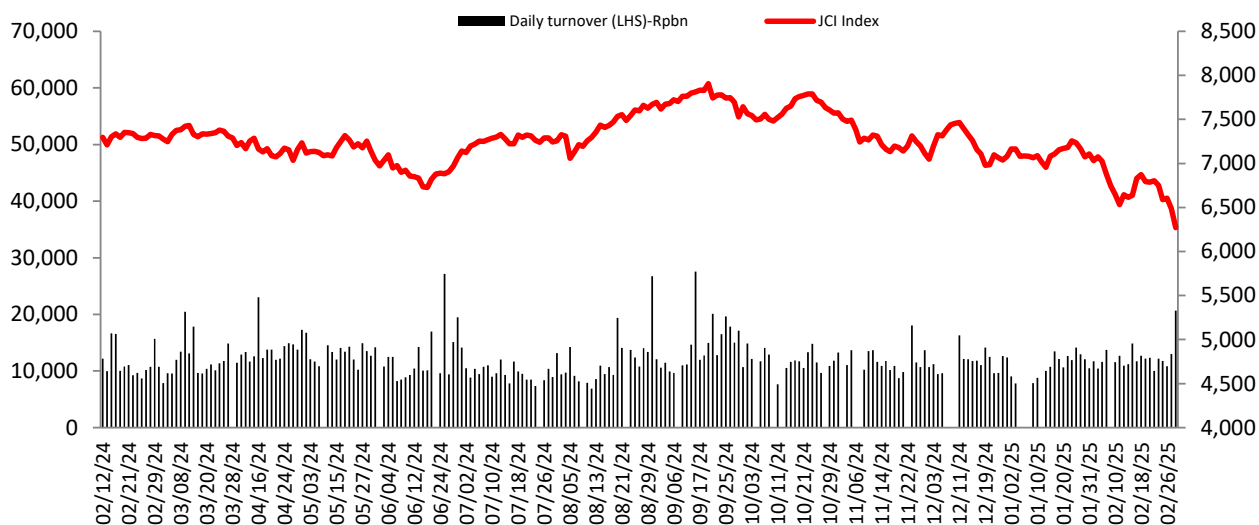
BOND MARKET

Unchanged Sentiment

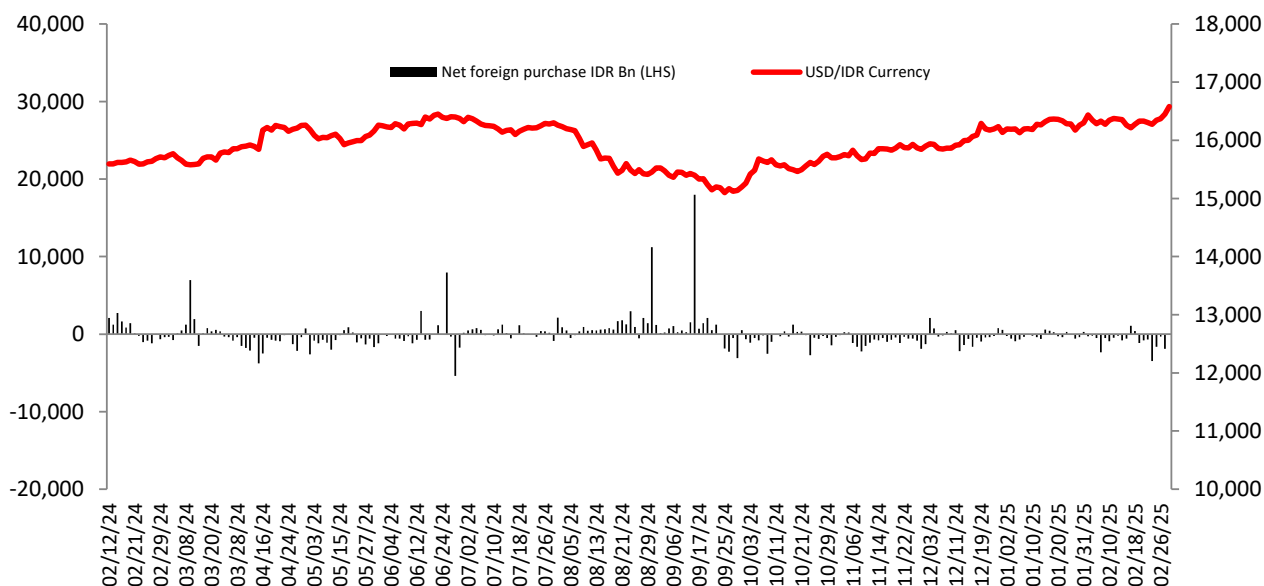
Indonesia bond market closed the week with unchanged sentiment despite Rupiah weakening against USD, traded above 16,550 level. Market is still moving two ways in the morning session, although in the second session bond market was pretty quiet. Trading concentrated on front to middle maturities while the other part of the yield curve was quoted within range throughout the day. IDR bond the prices ended the day unchanged from yesterday level. The 5Y/10Y/15Y/20Y benchmark closed the week at mid yield of 6.72%/6.90%/7%/6.99%. Spot closed at 16,596.
