DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

CORRECTED

JCI weakened and closed at 6,995 (-91 points or -1.29%) today. Shares across regional markets were negative. Meanwhile, foreign investors recorded net inflow of IDR 377Bn today and rupiah weakened to IDR 14,681/USD.

Banking stocks were mostly negative as BBNI (-0.6%), MEGA (-2.16%), BMRI (-0.92%), and BBRI (-1.36%) all closed lower, except PNBN (+6.51%). Consumer names were mostly negative as MYOR (-1.52%), HMSP (-1.86%), INDF (-0.73%), and UNVR (-1.26%) all down, except ICBP (+1.18%). Mining stocks were negative as ANTM (-1.31%), INDY (-5.3%), ITMG (-2.6%), INCO (-2.7%), and ADRO (-7%) all corrected. Cement names were negative as SMCB (-0.9%), SMBR (-2.41%), INTP (-2.66%), and SMGR (-5.07%) all closed lower. Other movers were KIOS (+24.83%), BELL (+9.25%), BBHI (-6.81%), and EMTK (-6.2%).

Indonesia announced on Friday its first cases of the highly contagious Omicron subvariants BA.4 and BA.5 as the country starts to see an uptick in transmission following the Idul Fitri holiday season last month, which saw tens of millions of people traveling across the archipelago.


SLOW DAY


