INDONESIA MARKET WRAP

EQUITY MARKET

SLIDE DOWN

JCI weakened and closed at 6,810 (-63 points or -0.92%) today. Shares across regional markets were negative. Meanwhile, foreign investors recorded net outflow of IDR 38Bn today and rupiah was stabilized at IDR 15,202/USD.

Banking stocks were mostly negative as BBKA (-0.29%), BBNI (-2.21%), BBRI (-1.24%), and BMRI (-1.96%) all down, except MEGA (+1.8%). Consumer names were mostly negative as MYOR (-1.5%), ICBP (-0.73%), GGRM (-4.23%), and KLBF (-5.68%) all declined, except INDF (+1.15%). Retailer stocks were negative as MAPA (-2.82%), ACES (-3.67%), LPPF (-2.38%), and AMRT (-0.98%) all retreated. Infra names were negative as JSMR (-1.42%), PGAS (-1.91%), TBIG (-2.79%), and TOWR (-2.27%) all corrected. Other movers were HRTA (+24.8%), AUTO (+6.8%), BRIS (-6.76%), and ARTO (-6.76%).

The gov't will increase the price of low cost green cars (LCGC) by 5% to adjust for increased production and logistics costs. With this plan, the LCGC benchmark price will increase by Rp6.7mn-Rp141.7mn.

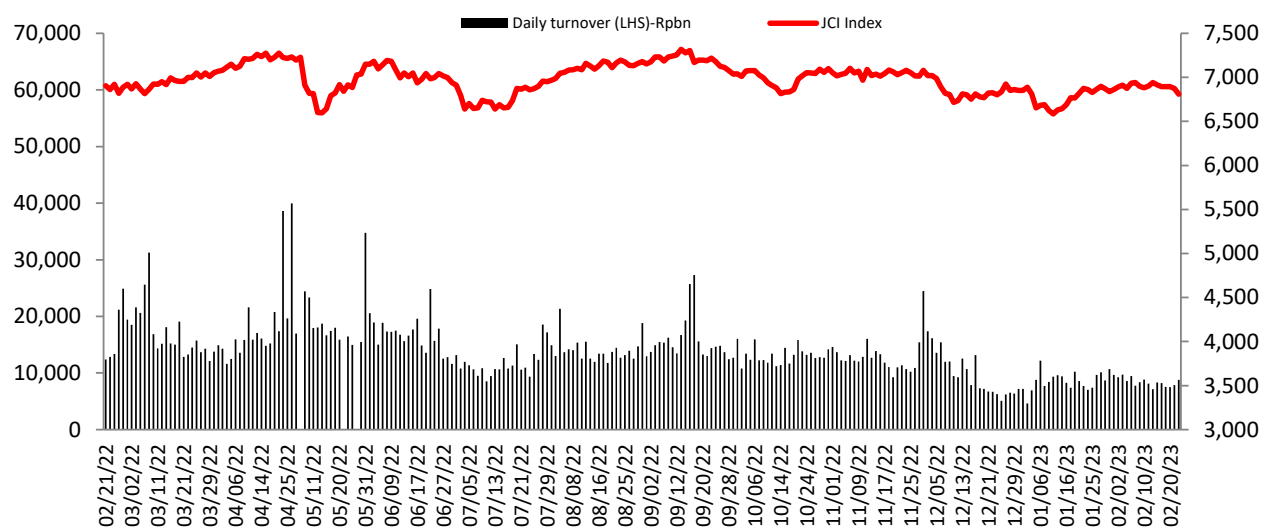

HIGHER YIELD

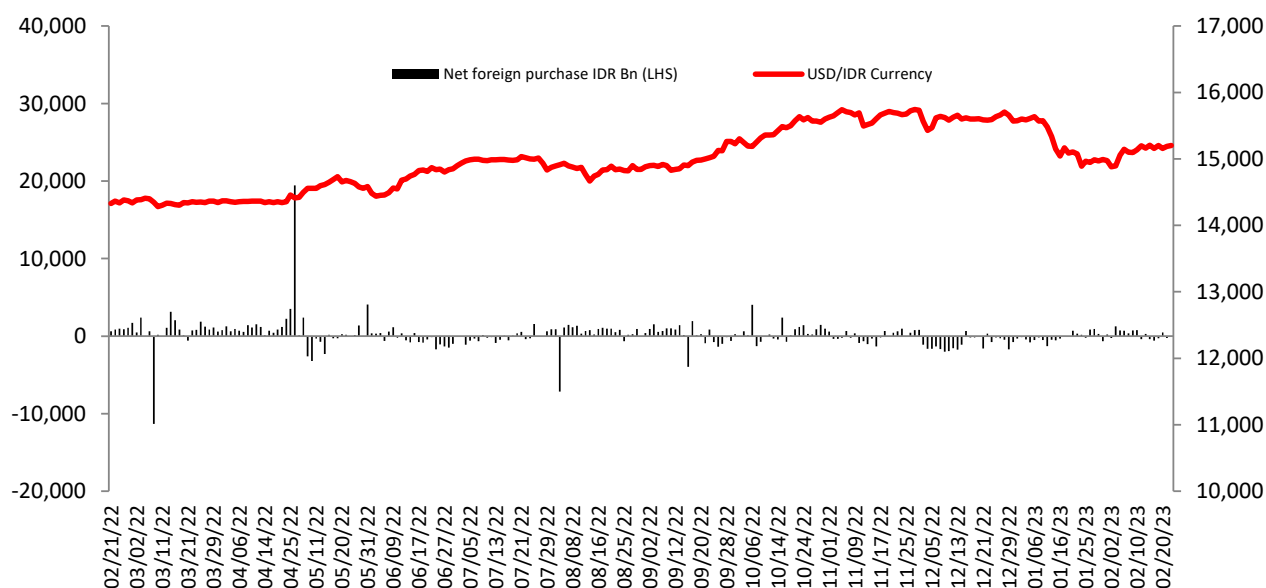
Indonesia bond market closed the day with higher yield around 5 – 7 bps followed by rupiah traded above 15,215 and UST touched at 3.95%. Selling pressure from interbank and foreign names remained thick in the air. Although we saw few bottom fishers came into the market, the buying failed to lend a support as prices went further south. The 5Y FR95/10Y FR96/15Y FR98/20Y FR97 closed the day at mid yield of 6.45%/6.77%/7.03%/7.06%.
