# DAILY REPORT INDONESIA MARKET WRAP

#### **EQUITY MARKET**

#### **Pullback**

JCI slightly weakened and closed at 7,308 (-18 points or -0.24%) today. Shares across regional markets were negative. Meanwhile, foreign investors recorded net inflow of IDR 474Bn today and rupiah slightly strengthened to IDR 16,200/USD.

Banking stocks were mixed as BMRI (+0.74%), BBNI (+0.49%), and MEGA (+0.5%) rose, while BBRI (-0.84%) and BBCA (-1.69%) corrected. Consumer names were mostly negative as KLBF (-0.61%), MYOR (-2.37%), INDF (-0.81%), and UNVR (-2.8%) all down, except ICBP (+1.59%). Telco stocks were negative as FREN (-3.33%), ISAT (-3.27%), and TLKM (-1.04%) all down. Retailer names were mixed as MAPI (+4.29%) and MAPA (+1.74%) in green, while ACES (-4.4%) and AMRT (-3.9%) retreated. Other movers were DSSA (+5.88%), BSDE (+4.35%), ESSA (-4.76%), and BFIN (-4.26%).

Indonesia July CPI +2.1% YoY, -0.18% MoM. Indonesia's consumer prices rose 2.13% in July from the previous year. Core inflation +1.95% y/y, food, drinks & tobacco +3.66% y/y, health +1.77% y/y.

### **BOND MARKET**


#### **WITHIN RANGE**

Indonesia bond market closed the week relatively flat. The mixed sentiment continued to be seen in the bond market today with the bond price opened around the same level as yesterday's closing. We witnessed several sporadic activity although the volume was very limited. Overall, IDR bonds yield lower 1 – 2 bps compared to yesterday closing and IDR bonds still traded within range. The benchmark of 5Y, 10Y, 15Y and 20Y closed at mid yields of 6.68%, 6.83%, 6.95% and 7% respectively.


