DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

REBOUNDED

JCI advanced and closed at 6,703 (+42 points or +0.63%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 62Bn today and rupiah slightly strengthened to IDR 14.945/USD.

Banking stocks were positive as BBCA (+0.83%), BBRI (+0.45%), BBTN (+3.08%), BBNI (+0.28%), and PNBN (+1.83%) all in green. Consumer names were mostly positive as INDF (+3.15%), UNVR (+1.4%), ICBP (+1.12%), and GGRM (+2.86%) all rose, except KLBF (-0.97%). Retailer stocks were positive as ACES (+14.05%), MAPI (+2.65%), AMRT (+0.39%), and MAPA (+1.54%) all closed higher. Hospital names were mixed as SILO (+0.26%) in green, while HEAL (-0.74%) and MIKA (-3.7%) declined. Other movers were ARTO (+10.65%), BRMS (+8.59%), SSMS (-5.04%), and IMPC (-4.88%).

The government has released new regulation that allows subsidised housing to be exempted of the value-added tax (VAT), and also raised the minimum price for these houses to Rp162-234mn from previously Rp150.5-219mn. Next year, the minimum price would be further raised to Rp166-240mn.

BOND MARKET


WITHIN RANGE

The mixed sentiment continued to be seen in the bond market today with the bond price opened around the same level as yesterday's closing. We witnessed several sporadic activity although the volume was very limited. Overall, IDR bonds yield lower 3 – 4 bps compared to yesterday closing, but IDR bonds still traded within range. The benchmark of 5Y, 10Y and 15Y closed at mid yields of 5.93%, 6.27% and 6.49% respectively. Spot closed at 14.952.


