# DAILY REPORT INDONESIA MARKET WRAP

#### **EQUITY MARKET**

#### **Staying Strong**

JCI advanced and closed at 7,092 (+48 points or +0.68%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 897Bn today and rupiah was stabilized at IDR 15,568/USD.

Banking stocks were mostly positive as BBCA (+1.75%), BBRI (+1.55%), BBNI (+1.36%), and MEGA (+1.39%) all inched higher, except PNBN (-0.76%). Consumer names were mixed as HMSP (+4.98%), SIDO (+3.5%), and GGRM (+1.9%) up, while UNVR (-0.93%) and KLBF (-1.47%) corrected. Retailer stocks were positive as AMRT (+2.26%), MAPI (+5.49%), ACES (+6.54%), and ERAA (+3.88%) all rose. Material names were positive as BRPT (+4.97%) and TPIA (+1.26%) all rose. Other movers were BFIN (+8.46%), BTPS (+7.19%), ADHI (-5.6%), and BIPI (-4.14%).

## **BOND MARKET**


#### (Still) Firmer

IndoGB opened firmer today following lower UST which briefly dipped below 4% overnight. Buying interest were seen led by 5Y FR90 and 15Y FR93 which got traded as high as 92.6 (7.08%) and 89.9 (7.52%) respectively. However, the good sentiment did not sustained till the end of the day as UST yield moved higher again in the afternoon session. Market went quiet and yield curve closed the day lower around 5-14bps. Tonight, market awaits for the US GDP data and ECB policy rate decision.


