DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Lower

JCI weakened and closed at 6,258 (-123 points or -1.94%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 2.3Tn today and rupiah slightly weakened to IDR 16,500/USD.

Banking stocks were mostly negative as BBTN (-5.52%), BBNI (-7.6%), BMRI (-4.55%), and BBCA (-5.67%) all declined, except BBRI (+1.09%). Consumer names were mostly negative as GGRM (-2.93%), HMSP (-3.6%), INDF (-0.71%), and MYOR (-6.94%) all declined, except KLBF (+2.75%). Retailer stocks were negative as LPPF (-3.66%), MAPI (-2.72%), MAPA (-9.7%), and AMRT (-8.92%) all retreated. Mining names were negative as TINS (-3.72%), ITMG (-1.86%), INCO (-6.96%), PTBA (-3.73%), and ANTM (-3.65%) all down. Other movers were POLU (+24.7%), PADI (+9.43%), MSIN (-20.97%), and BRMS (-7.61%).

President Prabowo ensure the three million housing program to continue during his presidency term. So far, total number of subsidized housing constructed and disbursed has reached more than 130k unit.


Higher Yield

Indonesia bond market closed the week with higher yield around 6 – 10 bps. The offerish tone was led by short end bonds after the SRBI auction result. Meanwhile, the belly and the long-end area also remained under selling pressure from offshore players. Although we saw few bottom fishers came into the market, the buying failed to lend a support as prices went further south. The 5Y FR104/10Y FR103/15Y FR106/20Y FR107 closed the week at mid yield of 6.88%/7.16%/7.17%/7.17%


