## INDONESIA MARKET WRAP

---

### EQUITY MARKET

#### Correction

JCI weakened and closed at 8,281 (-115 points or -1.37%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 1.4Tn today and rupiah slightly weakened to IDR 16,823/USD.

Banking stocks were mixed as MEGA (+24.7%) and BMRI (+1.9%) advanced, while BBNI (-1.11%), BBRI (-0.77%), and BBCA (-1.03%) declined. Consumer names were negative as GGRM (-3.68%), INDF (-0.75%), KLBF (-1.85%), HMSP (-4.92%), and ICBP (-2.45%) all corrected. Retailer stocks were negative as LPPF (-1.03%), MAPA (-3.47%), AMRT (-0.83%), and MAPI (-4.41%) all corrected. Material names were mixed as TPIA (+0.7%) closed higher, while BRPT (-5.14%) declined. Other movers were PPRE (+24.32%), PTPP (+6.86%), RISE (-12.24%), and DEWA (-8.94%).

Bank Indonesia (BI) reported that the broad money supply, or M2, reached Rp10,133.1 trillion in January 2026. This figure grew by 10% year on year (YoY), higher than the previous month's growth of 9.6% YoY.

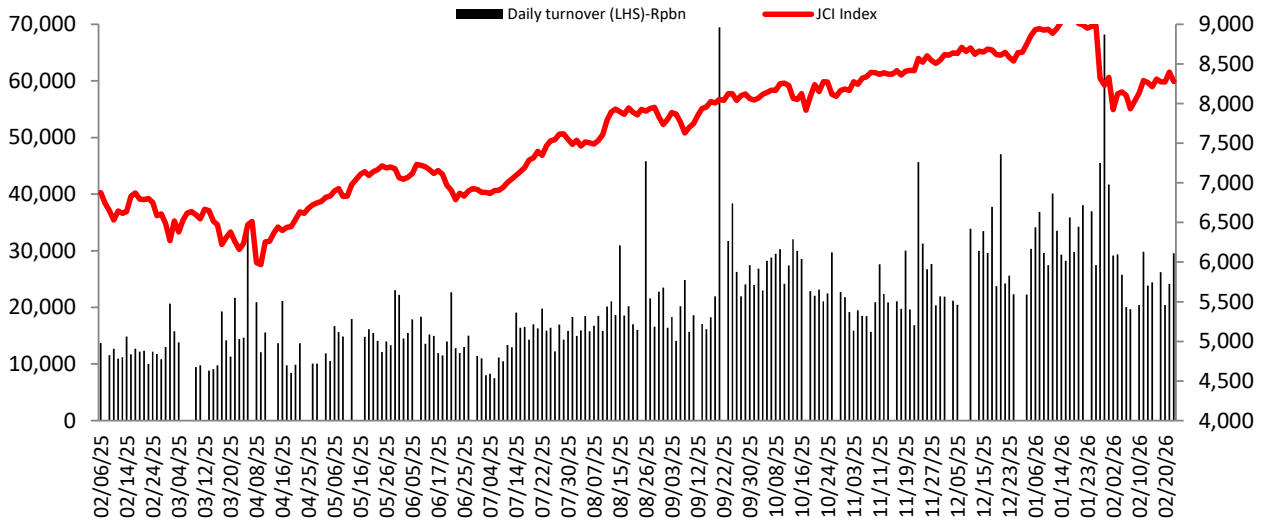
### BOND MARKET

#### SUKUK AUCTION

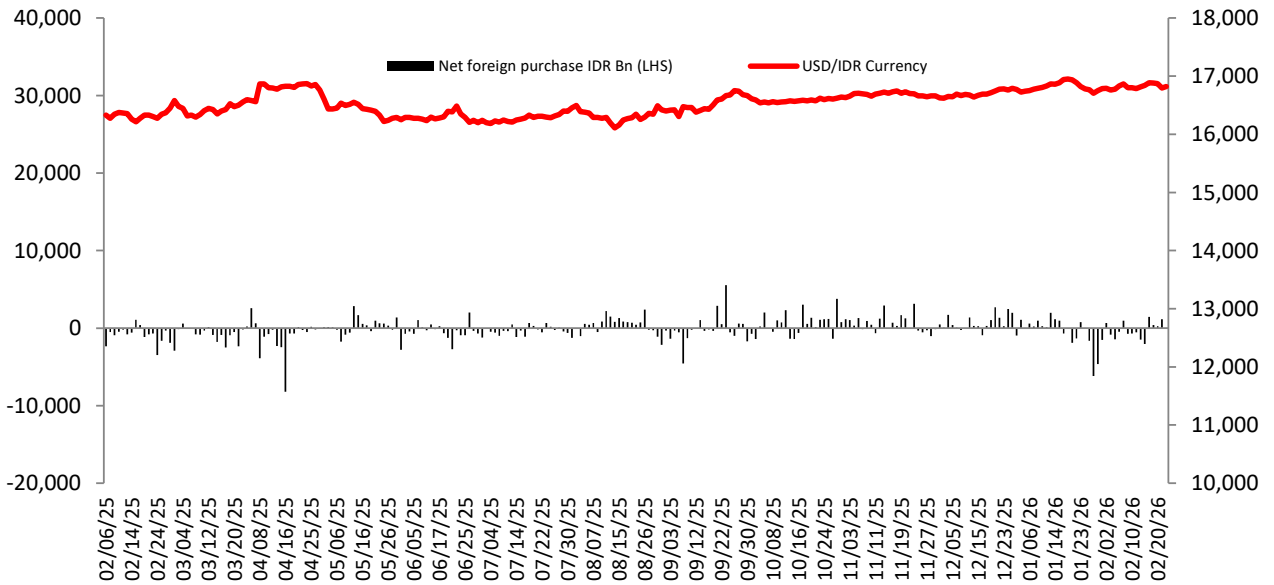
The bond market opened wide bid-and-ask spread following Rupiah trading slightly above 16,820 level and 10Y UST yield at 4.05% today. Prices moved range bound throughout the day with overall market tone was mixed. The market witnessed two way trading flow across the board. Yield curve closed lower around 2 to 3 bps compared to yesterday closing. In today sukuk auction, MoF receive interest gathering a total of IDR 35.61Tn incoming bids. MoF issued IDR 20Tn upsized from initial target IDR 11Tn. The series absorbed (against incoming bids) on the auction were IDR 0.4Tn (IDR 0.53Tn) 3mo SPN-S, IDR 2.35Tn (IDR 2.4Tn) 6mo SPN-S, IDR 6.25Tn (IDR 6.35Tn) 9mo SPNS, IDR 3.25Tn (IDR 10.895Tn) 2Y PBS30, IDR 0.5Tn (IDR 1.24Tn) 4Y PBS40, IDR 1.6Tn (IDR 2.22Tn) 13Y PBS34, IDR 2.2Tn (IDR 2.942Tn) 17Y PBS005 and IDR 3.45Tn (IDR 9.031Tn) 23Y PBS38 at cut off yields of 4.45%, 4.6%, 4.8%, 5.23%, 5.64%, 6.44%, 6.63% and 6.7% respectively.
