DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Higher

JCI slightly strengthened and closed at 6,899 (+19 points or +0.27%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 91Bn today and rupiah was stabilized at IDR 15,023/USD.

Banking stocks were negative as BBNI (-0.28%), BBTN (-2.57%), BBRI (-0.44%), BBCA (-0.55%), and BMRI (-0.9%) all closed lower. Consumer names were mixed as HMSP (+1.03%), ICBP (+0.22%), and KAEF (+0.6%) advanced, while GGRM (-0.34%) and INDF (-0.68%) closed lower. Mining stocks were mostly positive as ADRO (+2.07%), ITMG (+4.58%), PTBA (+3.23%), and INDY (+1.92%) all up, except TINS (-3.08%). Infra names were mixed as PGAS (+1.09%) and TBIG (+2.02%) advanced, while JSMR (-1.79%) and TOWR (-3.3%) down. Other movers were BBHI (+7.56%), BIPI (+7.2%), KIJA (-9.84%), and SCMA (-7.1%).

Indonesia's ministry of investment posted investment realization of IDR350tn in 2Q23, +14.2% y-y (Q1: +20.2%) . Foreign investment accounts for 53% while the rest is domestic. Logistics, transports, warehouse and basic metal non-machinery are top two invested sectors.

BOND MARKET

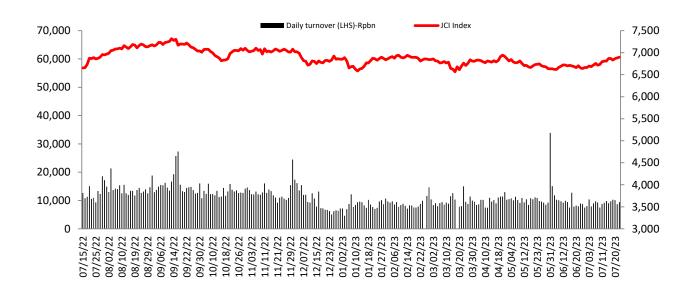
CALM MARKET

Indonesia bond market was quiet for most part of the trading day. Market players turned defensive and stay sidelined ahead of government bond auction, Central Banks meetings tomorrow and some important economic data. Limited flow was seen on the benchmark series throughout the day. The benchmark series 5Y/10Y/15Y/20Y closed at mid-yield of 5.9%/6.24%/6.36%/6.44% respectively. Tomorrow, Indonesia Debt Management Office ("DMO") will hold its regular bond auction. The series that will be issued are 3M SPN, 12M SPN, 5Y FR95, 10Y FR96, 15Y FR98, 20Y FR97 and 30Y FR89. In the previous conventional auction, incoming bids reached IDR 47.797Tn and DMO issued IDR 13Tn.

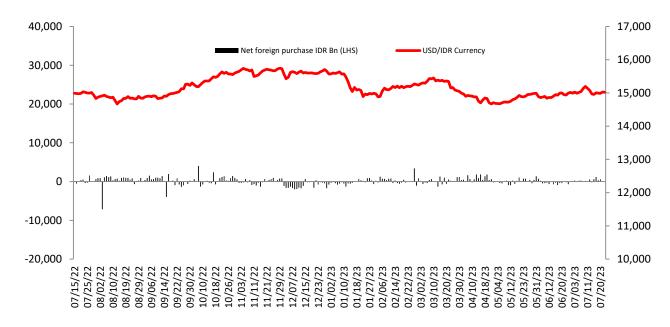
