DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

ADJUSTED DOWN

JCI weakened and closed at 6,053 (-34 points or -0.55%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net outflow of IDR 35Bn today and rupiah slightly strengthened to IDR 14,548/USD.

Banking stocks were mixed as BBRI (+0.92%) and BBTN (+4.43%) in green, while BBCA (-0.08%), BBNI (-1.26%), and BMRI (-1.19%) closed lower. Consumer names were mixed as KAEF (+7.57%) and SIDO (+1.91%) rose, while MYOR (-1.17%), UNVR (-0.4%), and HMSP (-1.13%) declined. Pulp & paper stocks were negative as TKIM (-6.02%) and INKP (-6.05%) all closed lower. Telco names were negative as ISAT (-1.92%), FREN (-6.32%), and TLKM (-0.6%) all corrected. Other movers were RALS (+10.18%), INPP (+10.16%), AMRT (-4.15%), and EMTK (-3.92%).

As of February 2021, the number of e-commerce transactions increased significantly by 107.1% YoY to 174.6mn transactions. The transaction value also reached Rp27.2tn, (+ 45.3% YoY).

BOND MARKET


SLIGHTLY HIGHER

Indonesia bond market started the week with biddish sentiment following stabilized 10Y UST at 1.55%. In the morning session we heard several buyer and profit takers came to the secondary market. However, the flow did not sustain and market turned quiet after that. In the afternoon session as soon as London opened, bidders continue to give flow to secondary and brought the yield lower by around 4 – 7 bps especially on 5Y FR86 an 10YFR87 as the most traded bonds today. Tomorrow on April 20th MoF will hold regular Sukuk auction of 6M SPNS, 2Y PBS-027, 4Y PBS-017, 13Y PBS-029, 16Y PBS-004 and 25Y PBS-028 with indicative target of IDR 10Tn.


