INDONESIA MARKET WRAP

EQUITY MARKET

STILL UP

JCI slightly strengthened and closed at 6,918 (+18 points or +0.27%) today. Shares across regional markets were positive. Meanwhile, foreign investors recorded net inflow of IDR 636Bn today and rupiah slightly strengthened to IDR 14,993/USD.

Banking stocks were mixed as BBRI (+0.89%), BMRI (+0.91%), and BBKA (+0.55%) advanced, while PNB (-1.99%) and MEGA (-0.5%) weakened. Consumer names were negative as GGRM (-1.73%), MYOR (-2.4%), INDF (-1.37%), ICBP (-2.6%), and UNVR (-5.59%) all corrected. Telco stocks were mixed as FREN (+3.51%) advanced, while ISAT (-4.2%) and TLKM (-0.51%) corrected. Retailer names were mostly negative as ERAA (-1.65%), MAPA (-3.16%), and AMRT (-1.06%) all declined, except ACES (+2.04%). Other movers were MPRO (+11.65%), MEDC (+8%), BRMS (-7.07%), and TCPI (-5.71%).

The Ministry of Finance noted that the realization of fuel subsidies and compensation in 1H23 reached Rp57.7tn, electricity reached Rp42.9tn, LPG amounted to Rp32.5tn, in addition, housing subsidies amounted to Rp344.7bn for 84.5k housing units. Overall, the distribution of social protection subsidies and compensation (Perlinsos) reached Rp133.44tn

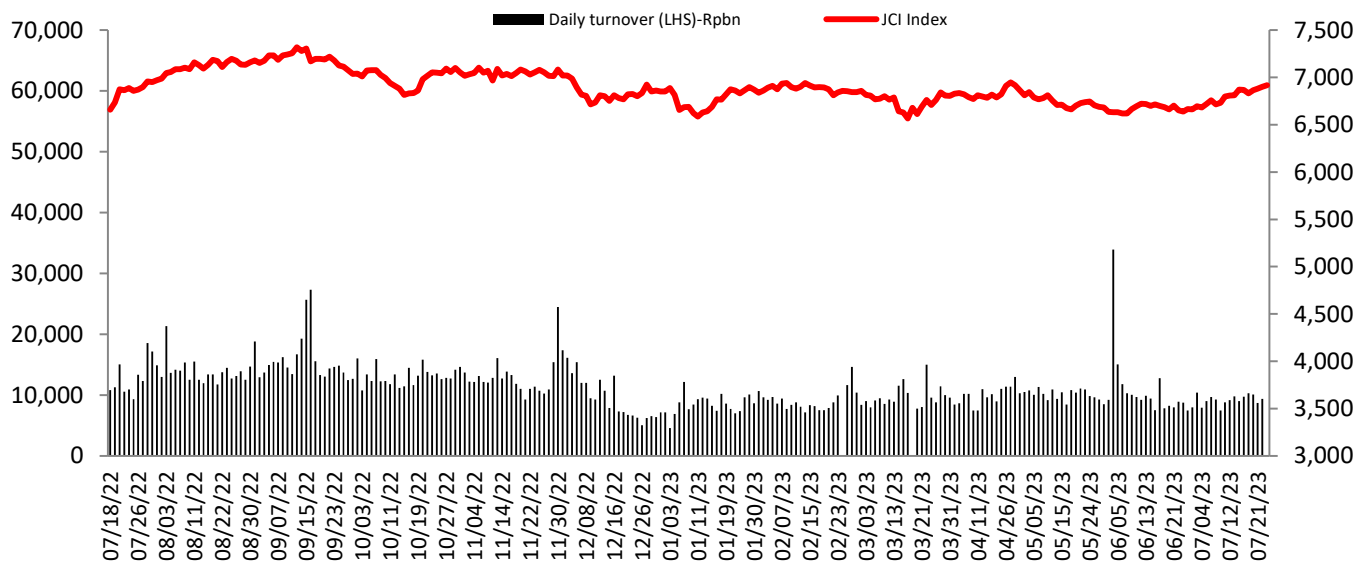
BOND MARKET

AUCTION DAY & BI STAYED AT 5.75%

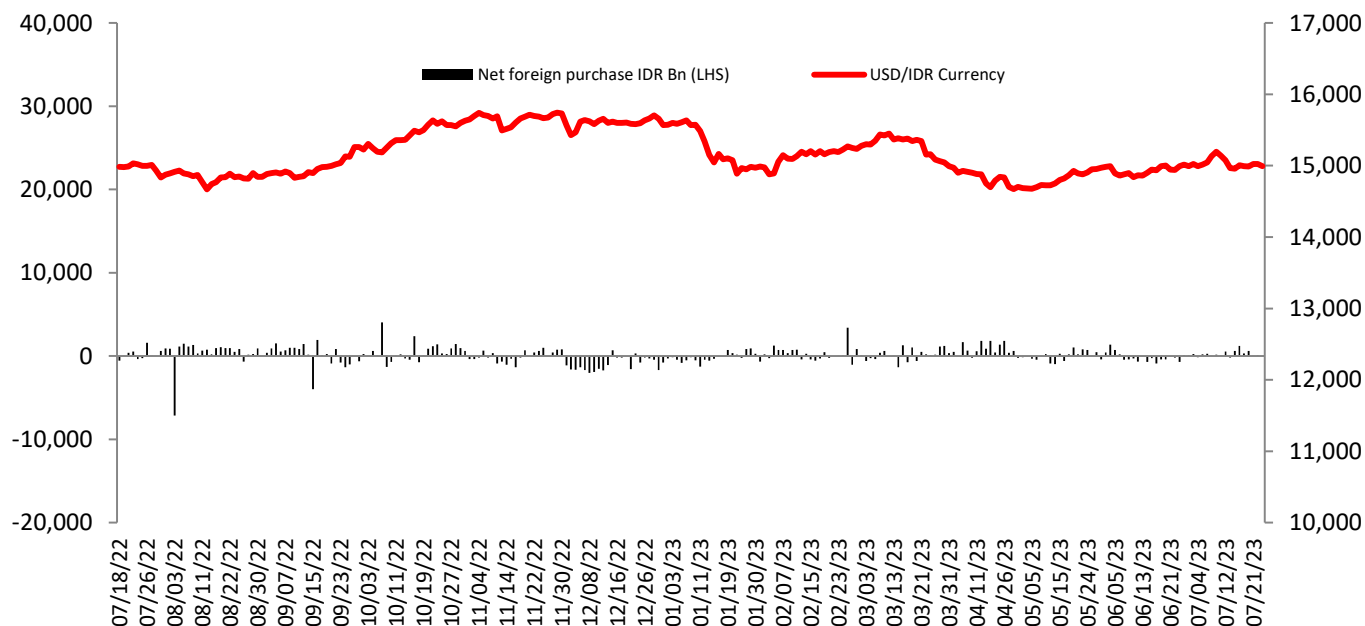
In Indonesia bond market closed the day with lower yield around 1 – 2 bps today. In the morning session, we heard onshore foreign banks and offshore players came to secondary to collect some short to middle tenors at aggressive level. While in the afternoon session, secondary market went weaker, BI seen selling front to belly tenors through state banks on secondary market. After auction result, Bank Indonesia announced that the central bank keep 7-days repo rate unchanged at 5.75% as expected. In today auction, MoF managed to downsized the issuance to IDR 13Tn from initial target IDR 14Tn. The series absorbed (against incoming bids) on the auction were IDR 0.75Tn (IDR 1.55Tn) 9mo SPN, IDR 2.35Tn (IDR 3.361Tn) 5Y FR95, IDR 4.1Tn (IDR 12.762Tn) 10Y FR96, IDR 2.3Tn (IDR 6.579Tn) 15Y FR98, IDR 1.3Tn (IDR 3.541Tn) 20Y FR97 and IDR 2.2Tn (IDR 3.201Tn) 30Y FR89 at weighted average yields of 5.38%, 5.9%, 6.2%, 6.34%, 6.44%, and 6.68% respectively.
