DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Foreign sell-off

JCI slightly weakened and closed at 7,695 (-22 points or 0.28%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 617Bn today and rupiah slightly weakened to IDR 15,640/USD.

Banking stocks were mostly positive as BMRI (+1.08%), BBCA (+0.47%), BNLI (+24.76%), and BBNI (+0.44%) all inched higher, except BBRI (-1.04%). Consumer names were mostly negative as MYOR (-1.14%), INDF (-0.33%), UNVR (-1.41%), and KLBF (-1.52%) all retreated, except ICBP (+1%). Properties stocks were negative as PWON (-0.85%), SMRA (-3.13%), BSDE (-2.02%), and LPKR (-6.06%) all corrected. Mining names were negative as INCO (-1.21%), TINS (-3.75%), PTBA (-1.37%), ADRO (-0.54%), and ANTM (-2.16%) all closed lower. Other movers were SONA (+24.22%), PANI (+5.46%), ISAT (-5.74%), and BUMI (-3.42%).

The Free Nutritious Meal Program is still scheduled to commence on January 2, 2025. The military (TNI) will be involved as an operational partner. This involvement is also reflected after Prabowo inaugurated Lodewyk Pusung as Deputy Head of the National Nutrition Agency.

BOND MARKET

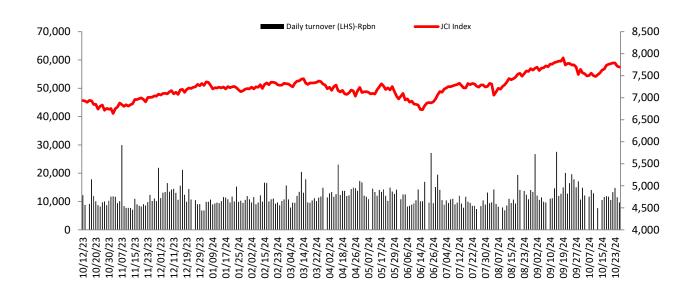
Slow Day

The bond market remained uneventful today. Only few trades were seen in the morning session with light trading volume, while in the afternoon session market went quiet. Prices moved in tight range throughout the day. From our side we only heard trade done in short and belly tenor. Overall the yield closed the day higher by around 1 – 2 Bps. There will be fresh supply next week as Indonesia Debt Management Office ("DMO") will hold conventional bond auction.

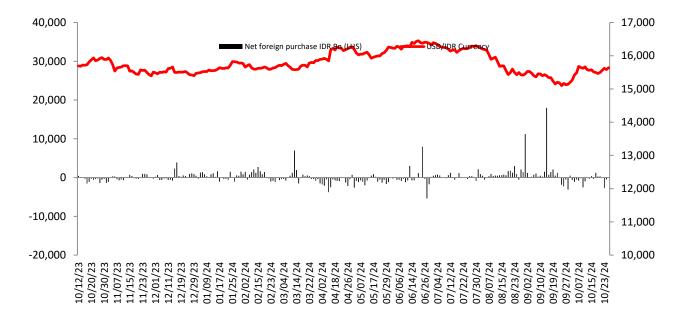
