Objectives and Investment Policy

The Fund seeks to increase the value of its assets over the medium term by investing mainly in shares of companies that are domiciled or do most of their business in a member state of the eurozone. The Fund may also invest a minor part of its assets in other shares, bonds and money market instruments. The Fund can use derivatives for hedging or efficient portfolio management. The Fund uses combination of market and fundamental company analysis to select companies that appear to be undervalued or to have an above-average potential for earnings growth (bottom-up approach).

The investment team applies also BNP PARIBAS ASSET MANAGEMENT Responsible Business Conduct Policy, including norm-based screens, exclusion lists and stewardship activities when taking into account Environmental, Social and Governance (ESG) criteria in the investments of the Fund.

This Fund is actively managed as the investment manager freely decide of the composition of its portfolio within the limits of the investment policy. The past performances of the Fund are nevertheless compared to the MSCI EMU, as detailed in the section "Past Performances" below.

Income are systematically reinvested.
