DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Correction

JCI weakened and closed at 7,108 (-48 points or -0.67%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 646Bn today and rupiah slightly weakened to IDR 16,300/USD.

Banking stocks were negative as BBTN (-2.08%), BBNI (-1.38%), BMRI (-0.49%), BBRI (-0.51%), and BBCA (-1.93%) all corrected. Consumer names were mostly negative as UNVR (-0.68%), MYOR (-1.45%), INDF (-0.91%), and KLBF (-2.82%) all weakened, except ICBP (+0.24%). Pulp & paper stocks were negative as TKIM (-3.69%) and INKP (-3.21%) all down. Material names were positive as TPIA (+0.98%) and BRPT (+0.98%) all in green. Other movers were ESSA (+15.57%), SSIA (+13.46%), KPIG (-6.02%), and INCO (-4.68%).

The Ministry of Finance reported that as of 5M25, the realization of state expenditure reached Rp1,016tn (-11% YoY; 28% of the budget). Meanwhile, state revenue reached Rp995tn (-11% YoY; 33% of the budget), where tax revenue amounted to Rp683tn (-1% YoY; 31% of the target).

BOND MARKET

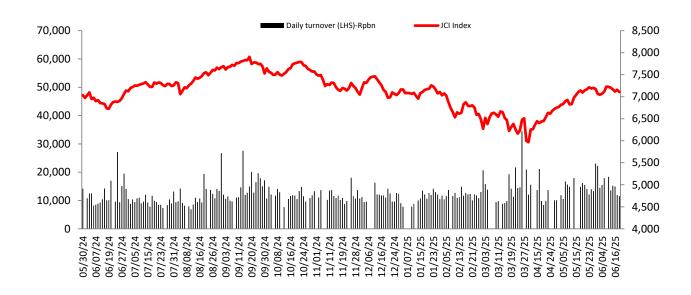
BI RATE STAYED AT 5.5%

It was a quiet day for the bond market. In the morning session, prices were quoted unchanged and spread widened ahead of BI rate meeting. In the afternoon session, Bank Indonesia announced that the central bank keep 7-days repo rate unchanged at 5.5% as expected. BI bought IDR 124T of government bonds YTD. Post the announcement, there was no significant price movement in the market with only limited trading was seen. Overall the yield curve lower by 1-2bps compared to yesterday's closing level.

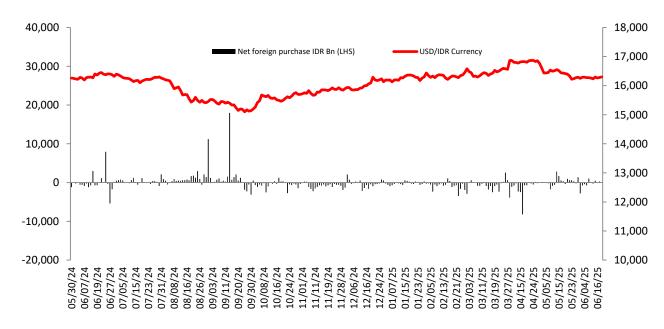
