DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Slightly Higher

JCI slightly strengthened and closed at 6,912 (+21 points or +0.31%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net inflow of IDR 1,250Bn today and rupiah was stabilized at IDR 14.893/USD.

Banking stocks were positive as BBRI (+3.26%), BBCA (+2.96%), BMRI (+2.06%), BBNI (+2.2%), and BBTN (+2.59%) all inched higher. Consumer names were mixed as ICBP (+2.2%), INDF (+1.52%), and MYOR (+4.17%) in green, while KLBF (-0.91%) and GGRM (-5.73%) retreated. Retailer stocks were positive as AMRT (+1.36%), LPPF (+4.91%), MAPA (+6.7%), and ERAA (+4.62%) all rose. Properties names were positive as SMRA (+4.07%), BSDE (+2.62%), PWON (+2.2%), and LPKR (+3.57%) all rose. Other movers were EMTK (+6.82%), BFIN (+5.44%), BRMS (-5.73%), and BIPI (-5.65%).

Jokowi confirms rising rice prices in all provinces. He said that the government is doing a market operation to bring down the price by disbursing 315 tonnes of government rice reserves at IDR8,300/kg.

BOND MARKET


Little Change

In the end market closed quiet with all eyes are now onto tonight's NPF data.


