INDONESIA MARKET WRAP

EQUITY MARKET

Higher on Close

JCI slightly strengthened and closed at 7,350 (+12 points or +0.16%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 373Bn today and rupiah weakened to IDR 15,780/USD.

Banking stocks were mixed as BBRI (+0.41%), BBTN (+9.47%), and BBNI (+0.86%) inched higher, while MEGA (-0.6%) and BBKA (-0.25%) declined. Consumer names were mixed as KLBF (+1.71%), ICBP (+1.6%), and KAEF (+24.52%) closed higher, while GGRM (-0.75%) and INDF (-0.39%) closed lower. Hospital stocks were positive as MIKA (+3.02%), HEAL (+1.2%), and SILO (+0.89%) all closed higher. Pulp & paper names were positive as INKP (+2.19%) and TKIM (+2.13%) all in green. Other movers were ESSA (+3.15%), EMTK (+2.78%), TINS (-6.43%), and MPRO (-4.36%).

The Ministry of Finance recorded that the realization of tax revenue as of February 2024 was Rp269.02tn, reaching 13.53% of the 2024 state budget, but down 3.9% YoY.

BOND MARKET

SLIGHTLY LOWER

JCI slightly strengthened and closed at 7,433 (+12 points or +0.16%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 1.9Tn today and rupiah was stabilized at IDR 15,582/USD.

Banking stocks were mixed as BBKA (+3.25%) and BMRI (+1.72%) in green, while MEGA (-3.83%), BBNI (-1.2%), and BBRI (-3.91%) retreated. Consumer names were mixed as INDF (+1.98%), ICBP (+1.63%), and KLBF (+0.7%) advanced, while MYOR (-1.25%) and UNVR (-1.1%) retreated. Mining stocks were positive as ADRO (+2.69%), PTBA (+2.86%), ANTM (+1.54%), ITMG (+1.48%), and INDY (+3.93%) all in green. Material names were mixed as BRPT (+0.98%) up, while TPIA (-10.84%) declined. Other movers were DSSA (+15.48%), MEDC (+9.02%), BRIS (-4.91%), and PANI (-3.67%).

Consumer optimism is decreasing ahead of the Ramadan momentum, as indicated by the decline in the Consumer Confidence Index (CCI) based on the results of the Bank Indonesia Consumer Survey. On Feb-24, the CCI was recorded at level 123.1, down from Jan's level of 125.

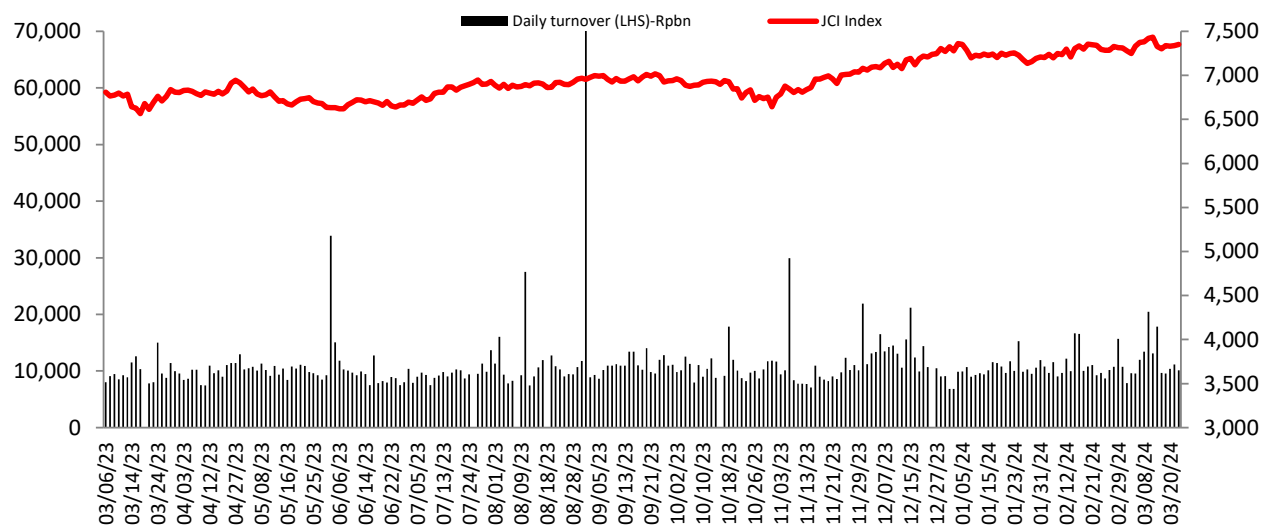

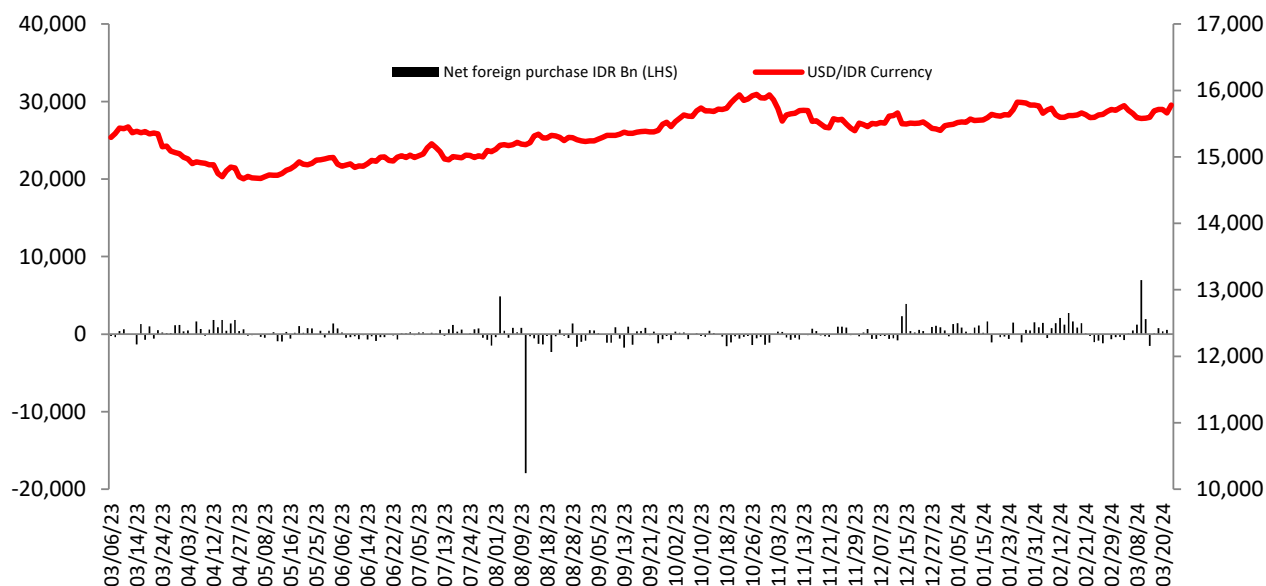
