DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Lower

JCI weakened and closed at 7,128 (-51 points or -0.71%) today. Shares across regional markets were negative. Meanwhile, foreign investors recorded net outflow of IDR 1,370Bn today and rupiah weakened to IDR 15,128/USD.

Banking stocks were positive as BBRI (+1.34%), MEGA (+6.98%), BBCA (+0.6%), BMRI (+0.54%), and PNBN (+3.52%) all closed higher. Consumer names were mixed as GGRM (+3.36%), ICBP (+0.83%), and KLBF (+0.27%) rose, while HMSP (-0.56%) and UNVR (-0.42%) weakened. Mining stocks were negative as INDY (-6.12%), PTBA (-3.49%), ANTM (-3.43%), ITMG (-4.51%), and ADRO (-4.69%) all retreated. Construction names were negative as ADHI (-4.38%), WSKT (-1.9%), WIKA (-5.42%), and PTPP (-6.57%) all declined. Other movers were MREI (+16.67%), BSIM (+4%), BUMI (-6.8%), and AKRA (-6.79%).

MoF Fiscal Policy Agency has predicted that Indonesia's economic growth will be above Q2's growth at 5.4%.

BOND MARKET


DIP LOWER

Bond prices went further south today triggered by selling activity from mostly local players. Selling pressure remains heavy on the benchmark series following the global risk off sentiment and weaker Rupiah. Few bottom buyers managed to somewhat stabilized the price in the second session. Overall, yield moved higher across the curve by 8-10bps with 10Y FR91 seen last traded at 93.20 (7.38%). There will be fresh supply tomorrow as Indonesia Debt Management Office ("DMO") will hold conventional bond auction with IDR 19th issuance target. The series that will be issued are 3M SPN, 1Y SPN, 5Y FR95, 10Y FR96, 15Y FR98, 20Y FR97 and 29Y FR89.


