DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

RECOVERED

JCI slightly strengthened and closed at 6,838 (+29 points or +0.43%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 108Bn today and rupiah was stabilized at IDR 15.700/USD.

Banking stocks were mostly positive as BMRI (+0.87%), BBCA (+0.57%), BBNI (+0.62%), and MEGA (+0.95%) all rose, except BBRI (-0.99%). Consumer names were mixed as INDF (+1.98%) and KLBF (+0.63%) rose, while HMSP (-1.52%), UNVR (-1.67%), and ICBP (-1.89%) corrected. Pulp & paper stocks were positive as INKP (+3.24%) and TKIM (+1.32%) all inched higher. Material names were negative as BRPT (-2.13%) and TPIA (-3%) all corrected. Other movers were FILM (+17.81%), PANI (+5.3%), ARTO (-5.34%), and AUTO (-4.53%).

A nationwide survey by Bank Indonesia (BI) has found that the consumer confidence index (CCI) strengthened in October after dipping in the previous month. The index reading was 124.3 last month, higher than the 121.7 logged in September, according to the survey published on Wednesday.


SOFTER

Indonesia bond market traded softer today ahead of conventional auction and US CPI data tomorrow. The market opened quiet with little to no trades heard on our side, but heard some selling in the afternoon in what looks like freeing up space for tomorrow auction. The most traded bonds today, 10Y FR96 were traded to 6.91% while 8Y FR87 were traded to 7.09%. Overall yield curve closed higher by 4-9 bps. Tomorrow, MoF would held conventional auction with issuance target of IDR 19tn (max: IDR 28.5tn). The series offered tomorrow are 3mo SPN, 12mo SPN, 5Y FR101, 10Y FR100, 15Y FR98, 20Y FR97, and 28Y FR89.


