INDONESIA MARKET WRAP

EQUITY MARKET

Slightly Lower

JCI slightly weakened and closed at 7,366 (-12 points or -0.16%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 407Bn today and rupiah was stabilized at IDR 15,790/USD.

Banking stocks were mixed as BBRI (+0.8%), BBNI (+0.42%), and MEGA (+1.11%) rose, while BBCA (-0.25%) and BMRI (-1.03%) closed lower. Consumer names were mixed as MYOR (+1.54%) and UNVR (+0.36%) up, while KLBF (-0.99%), INDF (-1.16%), and ICBP (-3.13%) corrected. Material stocks were positive as TPIA (+2.52%) and BRPT (+0.52%) all in green. Poultry names were negative as MAIN (-2.88%), JPFA (-2.1%), and CPIN (-1.42%) all weakened. Other movers were BALI (+17.95%), DSSA (+9.33%), GIAA (-9.86%), and ELTY (-8.89%).

Bank Indonesia (BI) recorded disbursement of MSME loans of Rp1,364tn during the first two months of 2024, up +9.4% YoY, higher than the previous month of +7.9% YoY.

BOND MARKET

Last Auction in 1Q24


JCI slightly strengthened and closed at 7,433 (+12 points or +0.16%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 1.9Tn today and rupiah was stabilized at IDR 15,582/USD.

Banking stocks were mixed as BBKA (+3.25%) and BMRI (+1.72%) in green, while MEGA (-3.83%), BBNI (-1.2%), and BBRI (-3.91%) retreated. Consumer names were mixed as INDF (+1.98%), ICBP (+1.63%), and KLBF (+0.7%) advanced, while MYOR (-1.25%) and UNVR (-1.1%) retreated. Mining stocks were positive as ADRO (+2.69%), PTBA (+2.86%), ANTM (+1.54%), ITMG (+1.48%), and INDY (+3.93%) all in green. Material names were mixed as BRPT (+0.98%) up, while TPIA (-10.84%) declined. Other movers were DSSA (+15.48%), MEDC (+9.02%), BRIS (-4.91%), and PANI (-3.67%).


Consumer optimism is decreasing ahead of the Ramadan momentum, as indicated by the decline in the Consumer Confidence Index (CCI) based on the results of the Bank Indonesia Consumer Survey. On Feb-24, the CCI was recorded at level 123.1, down from Jan's level of 125.
