DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

WEAKENED

JCI weakened and closed at 4,927 (-43 points or -0.87%) today. Shares across regional markets were mixed after President Trump said he and First Lady tested positive for the coronavirus. Meanwhile, foreign investors recorded net outflow of IDR 49Bn today and rupiah slightly weakened to IDR 14.865/USD.

Banking stocks were negative as BDMN (-2.2%), BBNI (-1.31%), BNLI (-4.24%), BBRI (-1.9%), and BBCA (-1.17%) all down. Consumer names were negative as INDF (-1.39%), ICBP (-0.74%), UNVR (-0.31%), KLBF (-2.48%), and HMSP (-1.4%) all corrected. Telco stocks were negative as FREN (-2.5%), EXCL (-4.55%), and TLKM (-2.55%) all weakened. Infra names were negative as TOWR (-1.42%), PGAS (-3.66%), TBIG (-2.89%), and JSMR (-3.58%) all declined. Other movers were KOTA (+13.21%), LINK (+11.05%), ADRO (-3.39%), and CPIN (-1.29%).

Central bureau of statistics (BPS) reported deflation of 0.05% MoM in Sep 2020. This marked the third months of consecutive deflation, with 0.1% in Jul and 0.05% in Aug. These were due to lower demand from low purchasing power. Core inflation is dropping to 0.13%, from 0.29% in Aug 2020.

BOND MARKET


THIN TRADING

The bond market was quiet for most part of the trading day as HK and China still on holiday. Bonds prices across the board underwent pressure after news of Trump's tested positive for Covid came out. We witnessed several sporadic activity on a thin market towards closing time as bottom fisher were seen collecting at the bottom. One of the most traded bonds today, 5Y FR81 touched at 5.75%. The 5Y/10Y/15Y/20Y benchmark closed the week at mid yield of 5.79%/6.89%/7.40%/7.39%.


