## INDONESIA MARKET WRAP

---

### EQUITY MARKET

#### FLAT

JCI was flat and closed at 6,633 (+0 points or +0%) today. Shares across regional markets were positive. Meanwhile, foreign investors recorded net inflow of IDR 722Bn today and rupiah advanced to IDR 14,890/USD.

Banking stocks were mixed as BBCA (+1.66%), BMRI (+0.5%), and PNB (+3.23%) rose, while BBNI (-0.55%) and BBRI (-2.69%) down. Consumer names were mixed as INDF (+2.11%), GGRM (+5.83%), and KLBF (+0.99%) up, while UNVR (-0.66%) and ICBP (-1.28%) closed lower. Mining stocks were positive as ADRO (+2.94%), ANTM (+4.22%), INCO (+4.76%), PTBA (+2.94%), and ITMG (+2.82%) all advanced. Material names were negative as BRPT (-3.95%) and TPIA (-4.67%) all corrected. Other movers were BUMI (+12.5%), BRMS (+12.07%), MREI (-14.36%), and FILM (-11.95%).

Gov't has set indicative ministerial expenditure ceiling for 2024 at Rp999.9tn, up 2.3% from the 2023 indicative ceiling. The largest is for the Ministry of Public Works and Public Housing amounting to Rp128.15tn, one of which will be used to work on the IKN project


### BOND MARKET

#### QUIET MARKET


Indonesia bond market was calm today. Only few trades were seen throughout the day with light trading volume. Although the overall market tone was mixed, no significant price action took place. IDR bond the prices ended the day unchanged from yesterday level. The yield of 5/10/15/20Y benchmark closed the day at mid-yield of 6.03%/6.38%/6.57%/6.66% respectively. Tomorrow on June 6th MoF will hold the regular Sukuk auction. The series offered are 6M SPNS, 2Y PBS-036, 4Y PBS-03, 6Y PBSG1, 13Y PBS-037 and 24Y PBS-033 with indicative target of IDR 9Tn.
