# DAILY REPORT INDONESIA MARKET WRAP

# **EQUITY MARKET**

#### **SLIDING UP**

JCI slightly strengthened and closed at 5,976 (+12 points or +0.2%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net inflow of IDR 165Bn today and rupiah was stabilized at IDR 14,435/USD.

Banking stocks were mostly positive as BBRI (+0.74%), BBCA (+0.39%), BBNI (+0.89%), and BBTN (+2.81%) all closed higher, except BMRI (-0.82%). Pulp & paper names were positive as TKIM (+9.59%) and INKP (+5.77%) all up. Consumer stocks were mixed as MYOR (+2.3%) and UNVR (+0.43%) rose, while GGRM (-0.84%), INDF (-1.14%), and KLBF (-1.7%) retreated. Material names were negative as TPIA (-0.52%) and BRPT (-2.5%) all down. Other movers were LIFE (+10.68%), UNTR (+2.78%), POLL (-6.84%), and BMAS (-6.78%).

Ministry of Finance mentions that the plan to increase the VAT is still being discussed. Currently the VAT rate is at 10%, while based on the law gov't can still increase the VAT to 15%.

## **BOND MARKET**

### WITHIN RANGE


Indonesia bond market opened in wide spread today. Market trading was active, particularly in the morning session and nearing closing time. Despite we heard several actions in the bond market, price movement was relatively within range. At the end of the day, the yield curve was slid lower by about 2 - 3 bps. Trading activities were mainly done in 10Y and 20Y area.




