DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

SLIGHT REBOUND

JCI slightly strengthened and closed at 6,626 (+11 points or +0.16%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 595Bn today and rupiah was stabilized at IDR 14,333/USD.

Banking stocks were positive as BBRI (+1.69%), BMRI (+1.39%), PNBN (+1.32%), BBTN (+0.57%), and BDMN (+0.42%) all rose. Consumer names were mixed as ICBP (+1.15%), INDF (+0.78%), and GGRM (+0.56%) rose, while UNVR (-0.47%) and HMSP (-1.01%) down. Telco stocks were negative as EXCL (-1.88%), FREN (-3.3%), and TLKM (-0.49%) all retreated. Mining names were mostly negative as ANTM (-0.44%), TINS (-2.27%), PTBA (-1.1%), and INCO (-1.27%) all weakened, except ADRO (+5.21%). Other movers were ASMI (+25%), PALM (+21.17%), GEMS (-6.58%), and BRMS (-6.35%).

The gov't will start booster vaccinations for Covid-19 in January 2022. The gov't will only cover booster vaccinations for the elderly and JKN Contribution Assistance Recipients (PBI). A ceiling price will be set for non-program booster vaccination products and services.

SLOW DAY


Bond market opened the day softer and bidders were on defensive mode. Overall market was relatively quiet with small trades on benchmark series. There is not much activity both from local and foreign. By the end of day yield curve closed slightly lower by 2-3 bps. In the afternoon, government announced November Trade Balance data recorded at \$3.51billon (vs consensus of \$4.45billion).




