DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

FLAT

JCI was flat and closed at 6,923 (-1 points or -0.02%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 74Bn today and rupiah slightly weakened to IDR 14,303/USD.

Banking stocks were mixed as BBNI (+2.25%) and BBCA (+0.32%) closed higher, while BMRI (-0.33%), MEGA (-3.34%), and BBRI (-3.72%) declined. Consumer names were mixed as SIDO (+3.09%) and MYOR (+2.18%) inched higher, while HMSP (-1.07%), UNVR (-1.75%), and ICBP (-2.58%) corrected. Construction stocks were positive as WSKT (+5.22%), WIKA (+9.36%), PTPP (+9%), and ADHI (+4.43%) all in green. Telco names were mixed as TLKM (+4.08%) and EXCL (+4.1%) inched higher, while ISAT (-0.93%) down. Other movers were TMAS (+13.41%), GEMS (+7.64%), BYAN (-5.59%), and SRTG (-2.52%).

Local news reported that President Jokowi is set to do groundbreaking of the new capital city Nusantara in East Kalimantan in mid-March 2022. The groundbreaking will be done after land and institutional problems are cleared.

BOND MARKET


LITTLE CHANGE

The bond market closed the week with slight improvement although prices continued to move within range. Market trading was active particularly in the afternoon session. Local names interest was seen in 5Y – 10Y tenors with offshore players were seen on the sell side. Some profit takers also came in to market and brought bond yields back to yesterday's level. As a result yield curve closed with little change with benchmark of 5Y/10Y/15Y/20Y closed at 5.54%/6.68%/6.67%/7.1%. Overall the yield closed the day lower by around 2-4 bps.


