DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

STILL UP

JCI slightly strengthened and closed at 7,465 (+11 points or +0.15%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 495Bn today and rupiah slightly weakened to IDR 15,915/USD.

Banking stocks were mostly positive as BBCA (+0.72%), BBRI (+0.46%), MEGA (+1.54%), and BBTN (+1.21%) all up, except BBNI (-0.49%). Consumer names were mixed as INDF (+0.61%) and SIDO (+0.86%) advanced, while MYOR (-0.37%), GGRM (-2.34%), and UNVR (-2.75%) weakened. Telco stocks were mixed as TLKM (+3.25%) inched higher, while EXCL (-2.18%) and FREN (-7.41%) corrected. Mining names were mostly negative as INDY (-2%), PTBA (-1.06%), ANTM (-1.54%), and ADRO (-4.4%) all corrected, except ITMG (+1.17%). Other movers were RAJA (+12.65%), PANI (+8.52%), DSNG (-7.59%), and EMTK (-3.23%).

Based on Gaikindo data, national car wholesale sales dropped by -3.7% MoM and -11.9% YoY to 74.3k units in November 2024. Cumulative sales in 11M24 reached 784.8k units (-14.7% YoY).

BOND MARKET


Auction Day

Indonesia bond market closed the day relatively flat. Mixed trading was seen ahead of US CPI data tomorrow. Lacking other catalyst to move the market, bond prices continue to move within range. Yields were higher by around 1 – 3 bps across the curve. In today sukuk auction, government received much improvement from the previous auction, incoming bids got higher at IDR 38Tn (vs previous IDR 29Tn) and MoF managed issued as per initial at IDR 22Tn. The series absorbed (against incoming bids) on the auction were IDR 6.7Tn (IDR 7.869Tn) 6Y FR104, IDR 11.15Tn (IDR 16.314Tn) 11Y FR103, IDR 2.6Tn (IDR 3.398Tn) 15Y FR98, IDR 1.15Tn (IDR 2.515Tn) 20Y FR97, IDR 0.3Tn (IDR 1.672Tn) 25Y FR102 and IDR 0.1Tn (IDR 2.132Tn) 30Y FR105 at weighted average yields of 6.87%, 7.02%, 7.09%, 7.10%, 7.11% and 7.12% respectively. No winner on 3mo SPN and 12mo SPN.


