INDONESIA MARKET WRAP

EQUITY MARKET

Trending Lower

JCI weakened and closed at 7,034 (-106 points or -1.49%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net outflow of IDR -1.2Tn today and rupiah weakened to IDR 16,260/USD.

Banking stocks were mostly negative as MEGA (-0.93%), BBNI (-0.88%), BBRI (-0.68%), and BBKA (-1.64%) all declined, except BMRI (+1.29%). Consumer names were mostly negative as HMSP (-1.97%), MYOR (-2.62%), INDF (-1.22%), and ICBP (-2.64%) all declined, except UNVR (+3.32%). Retailer stocks were mostly negative as ERAA (-1.98%), ACES (-1.21%), and AMRT (-1.43%) all weakened, except MAPA (+0.66%). Mining names were mixed as ADRO (+2.24%), ITMG (+2.36%), and PTBA (+0.81%) rose, while ANTM (-2.3%) and INCO (-4.23%) corrected. Other movers were SSIA (+4.05%), FILM (+3.57%), MDKA (-3.45%), and ASII (-3.14%).

National banking in 4M24 distributed MSME credit reaching Rp1,373.8tn, grew +8.1% YoY. This growth slowed down from the March 2024 position of 8.7% YoY.

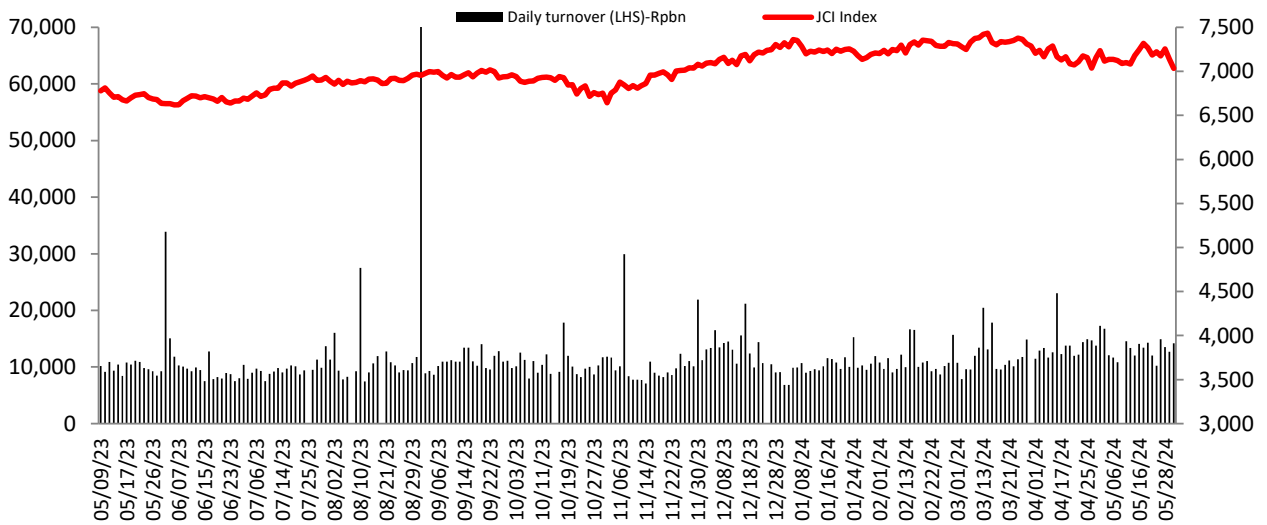
BOND MARKET

SLOW DAY

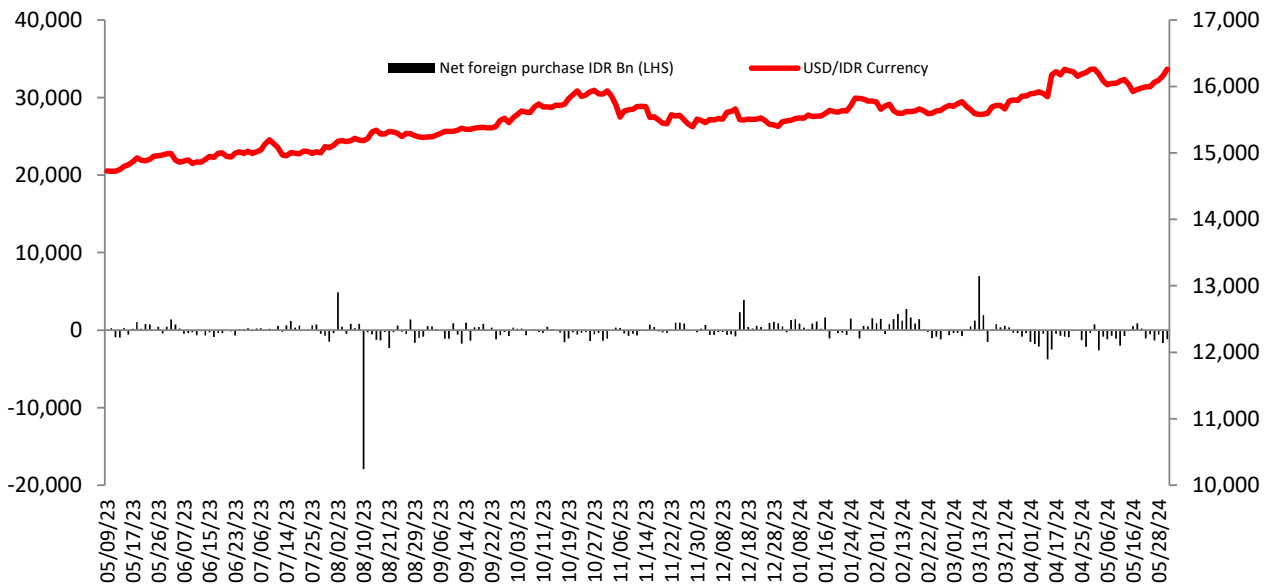
Bond market opened the day softer and wider as bidders were in defensive mode following UST weakness and stronger USD brought Rupiah to 16,280 today. Thin activity from local banks and interbank with only small inquiries during the day. Overall market was relatively quiet with small trades on benchmark series. By the end of day yield curve closed slightly higher by 1 – 2 bps. Market awaits for more US data coming tonight and tomorrow, namely GDP and PCE. There will be another SRBI auction tomorrow.
