DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

ADJUSTED DOWN

JCI weakened and closed at 6,830 (-37 points or -0.54%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net inflow of IDR 311Bn today and rupiah was stabilized at IDR 14,995/USD.

Banking stocks were mostly negative as MEGA (-0.99%), BBNI (-0.56%), BBCA (-0.27%), and BMRI (-0.47%) all retreated, except BBRI (+0.9%). Consumer names were mixed as ICBP (+0.86%), INDF (+0.68%), and GGRM (+0.63%) in green, while MYOR (-2.8%) and KLBF (-0.99%) declined. Telco stocks were negative as EXCL (-1.48%), ISAT (-1.11%), and TLKM (-1.53%) all retreated. Poultry names were negative as MAIN (-2.49%), JPFA (-0.72%), and CPIN (-1.84%) all corrected. Other movers were PEGE (+24.68%), PRDA (+4.12%), ARTO (-5.63%), and MDKA (-3.07%).


SUKUK AUCTION

It was a dull day for the bond market with relatively thin trading volume. After open the day unchanged, bond prices moved nowhere in the first trading session as we heard hardly any trade done. Some activities were seen in the front to belly area around 2Y and 7Y, suspecting BI on the offer side. Overall trading was pretty muted ahead of public holiday tomorrow. In today sukuk auction, MoF released the incoming bids data which amounts to IDR 23.42Tn, MoF managed to issued to IDR 6Tn. The series absorbed (against incoming bids) on the auction were IDR 0.75Tn (IDR 9.75Tn) 2Y PBS36, IDR 0.2Tn (IDR 1.22Tn) 13Y PBS3, IDR 1.75Tn (IDR 5.63Tn) 13Y PBS37, IDR 1.65Tn (IDR 3.46Tn) 16Y PBS34 and IDR 1.65Tn (IDR 2.25Tn) 24Y PBS33 at cut off yields of 5.85%, 5.75%, 6.46%, 6.48% and 6.69% respectively. No winner on 6mo SPNS.


