INDONESIA MARKET WRAP

EQUITY MARKET

Mixed

JCI was flat and closed at 7,829 (-3 points or -0.03%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 1.4Tn today and rupiah was stabilized at IDR 15,340/USD.

Banking stocks were mostly positive as BBCA (+1.19%), BBRI (+0.94%), BBNI (+0.88%), and BBTN (+2.77%) all closed higher, except BMRI (-0.34%). Consumer names were mixed as KLBF (+2.64%), ICBP (+0.88%), and UNVR (+1.38%) inched higher, while INDF (-0.35%) and HMSP (-1.99%) retreated. Properties stocks were positive as BSDE (+7.49%), SMRA (+4.62%), LPKR (+7.95%), and CTRA (+1.15%) all up. Mining names were negative as INDY (-1.67%), PTBA (-0.71%), INCO (-1.08%), ANTM (-1.09%), and ADRO (-2.93%) all retreated. Other movers were LIFE (+19.77%), GEMS (+5.59%), FILM (-5.69%), and TOWR (-5.33%).

The Coordinating Ministry for Maritime Affairs and Investment targets the market share of electric vehicles to reach 5% by the end of this year. In Indonesia, the market share of BEVs in 1H24 is still around 3%.

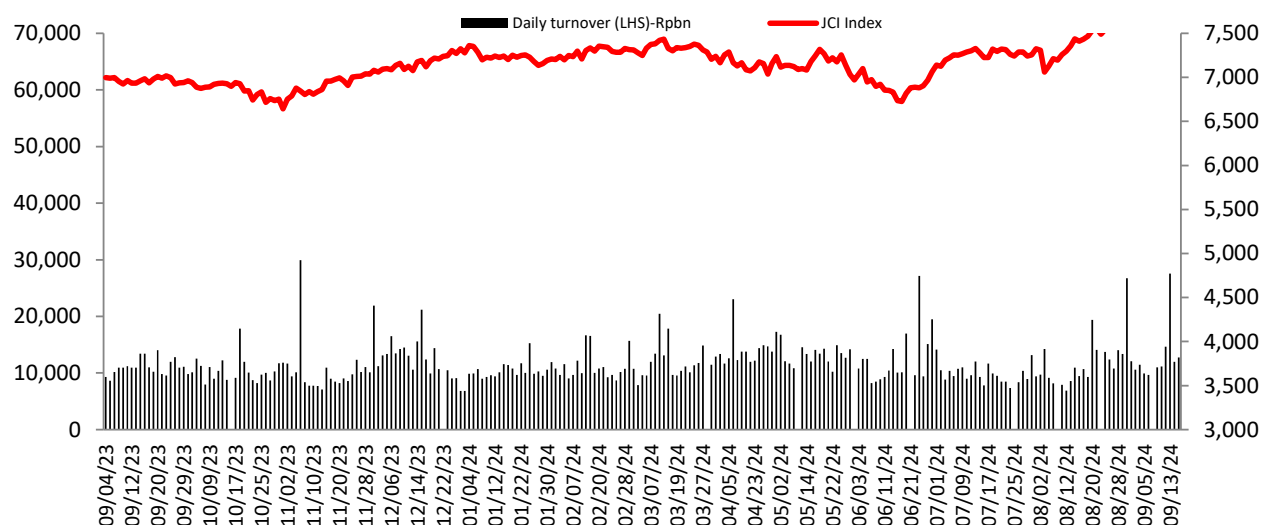
BOND MARKET

BI Cut 7DRRR to 6%

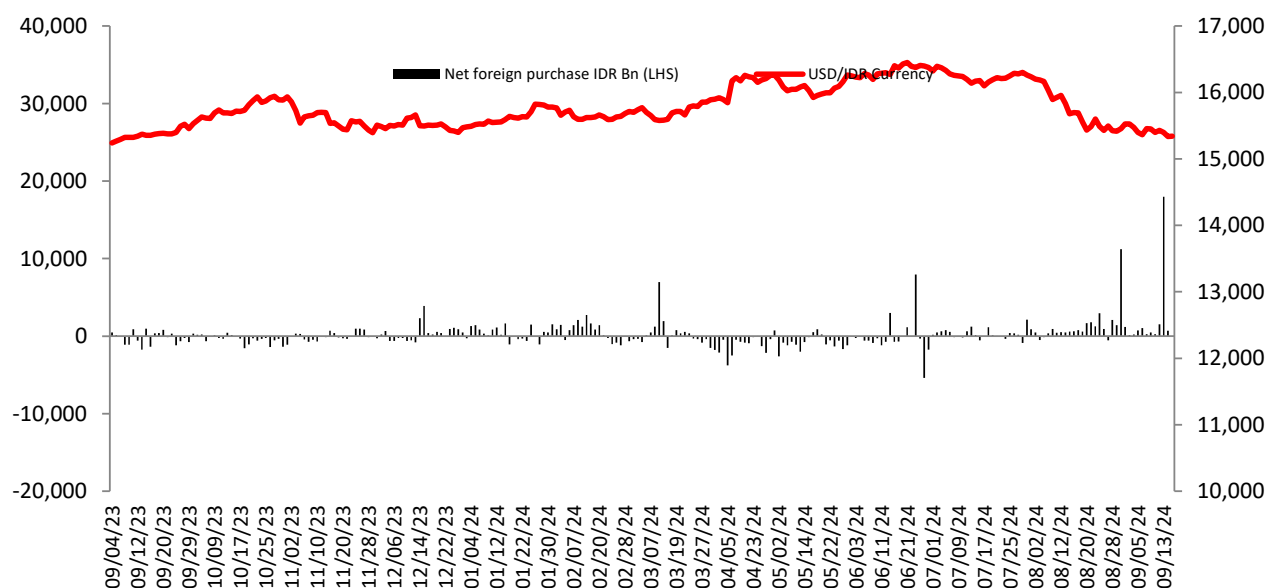
Indonesia bond market got quiet in the morning session ahead of BI rate meeting. No significant trade was heard. In the afternoon session, Bank Indonesia surprisingly cut its key interest rate for the first time in more than three years. Bank Indonesia cut their benchmark rate for 25 bps to level 6.00% while most economist expect that BI will hold its rate until the Fed starts cutting cycle. FOMC meeting are held tonight, with market in limbo as to whether it would be a 25bps or 50bps cut. After the announcement, market saw relatively mixed trading. The 5Y/10Y/15Y/20Y benchmark series closed the day with mid yield 6.37%/6/53%/6.66%/6.77%. Spot closed at 15,335.
