Investment policy

Η FCP αποσκοπεί στην επίτευξη δυναμικής κατανομής μεταξύ. αφενός, ένα «ενεργητικό-δείκτης» για την ασφάλιση των κατόχων (χωρίς να εξασφαλίζεται) Ότι κάθε αίτηση εξόφλησης θα υποβάλλεται σε καθαρή αξία ενεργητικού τουλάχιστον ίση με το 80% της μέγιστης καθαρής αξίας ενεργητικού που έχει επιτύχει το CPF μεταξύ της ημερομηνίας δημιουργίας του και της ημερομηνίας εξόφλησης και.

Από την άλλη πλευρά, ένα «διαφοροποιημένο χαρτοφυλάκιο περιουσιακών στοιχείων» που επιτρέπει στους κατόχους να είναι εν μέρει εκτεθειμένοι στην εξέλιξη (προς τα πάνω και προς τα κάτω) ενός δυναμικού χαρτοφυλακίου ΟΣΕΚΑ ή/και ΟΕΕ σε διάφορες κατηγορίες περιουσιακών στοιχείων, όπως περιγράφεται στην ενότητα «επενδυτική στρατηγική». Αυτός είναι ένας στόχος που δεν είναι σε καμία περίπτωση εγγυημένος. Στο πλαίσιο της κατανομής του, το CPF θα διασφαλίσει ότι τουλάχιστον το 75% των υποκείμενων αμοιβαίων κεφαλαίων στα οποία επενδύει προάγει τα περιβαλλοντικά ή κοινωνικά χαρακτηριστικά, ή συνδυασμό αυτών, υπό την προϋπόθεση ότι οι εταιρείες στις οποίες πραγματοποιούνται οι επενδύσεις εφαρμόζουν πρακτικές χρηστής διακυβέρνησης.

Η απόδοση του CPF θα εξαρτηθεί από την αντίστοιχη απόδοση των «διαφοροποιημένων στοιχείων ενεργητικού» και των «στοιχείων ενεργητικού επιτοκίων», όπως οι ΟΣΕΚΑ ή οι ΟΕΕ, και τα προϊόντα επιτοκίων. Η προσαρμογή της αναλογίας των στοιχείων ενεργητικού στο χαρτοφυλάκιο θα εξαρτηθεί από i) το περιθώριο που θα διατεθεί αφού ληφθούν υπόψη οι παράμετροι του στόχου για την επίτευξη κάθε ημέρας i), Καθαρή αξία ενεργητικού ίση τουλάχιστον με το 80% της υψηλότερης καθαρής αξίας ενεργητικού που επιτεύχθηκε από το CPF μεταξύ της ημερομηνίας δημιουργίας του και της ημερομηνίας της ημέρας i) και ii) των προσδοκιών του χρηματοοικονομικού διαχειριστή κατ' ανάθεση στις αγορές αναφοράς. Προκειμένου να πληρούνται οι απαιτήσεις του στόχου της απόκτησης κάθε ημέρας i), καθαρή αξία ενεργητικού τουλάχιστον ίση με το 80% της υψηλότερης καθαρής αξίας ενεργητικού που επιτυγχάνει το CPF μεταξύ της ημερομηνίας δημιουργίας του και της ημερομηνίας εκείνης της ημέρας i) ή/και εφόσον το απαιτούν οι συνθήκες της αγοράς. Το CPF μπορεί να επενδυθεί μόνο σε «περιουσιακά στοιχεία επιτοκίων» και, ως εκ τούτου, η έκθεση στο δυναμικό χαρτοφυλάκιο μπορεί να καταστεί και να παραμείνει μηδενική. Στην περίπτωση αυτή, το CPF δεν θα μπορούσε πλέον να συμβάλει στην πιθανή περαιτέρω αύξηση της αξίας των «διαφοροποιημένων στοιχείων ενεργητικού», μολονότι θα ήταν ισχυρό. Η διαχείριση του FCP είναι ενεργή. Η διαχείρισή του δεν γίνεται σε σχέση με έναν δείκτη αναφοράς.

GLOSSARY

Modified Duration (bond pocket)

A measure of a bond's sensitivity to changes in interest rates. The longer the remaining term to maturity, the more bond prices react to a change in interest rates, and the higher the duration. The rule is that if the yield rises or falls by 1%, the value of the bond will fluctuate by 1% x duration.

Sharpe Ratio

A measure for calculating risk-adjusted return. It indicates the return earned in excess of the risk-free rate per unit of risk. It is calculated by dividing the difference between the return and the risk-free rate by the standard deviation of the return on the investment. The Sharpe ratio indicates whether the excess return was obtained thanks to good investment management or by taking additional risk. The higher the ratio, the better the risk-adjusted return.

Volatility

An asset's volatility is the standard deviation of its return. As a measure of dispersion, it evaluates the uncertainty of asset prices, which is often equated to their risk. Volatility can be calculated ex post (retrospectively) or estimated ex ante (anticipatively).
