DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

INCHED UP

JCI slightly strengthened and closed at 6,931 (+31 points or +0.45%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net outflow of IDR 1.5Tn today and rupiah was stabilized at IDR 15.080/USD.

Banking stocks were mixed as BMRI (+0.44%), MEGA (+3.38%), and BBTN (+1.15%) advanced, while BDMN (-3.16%) and BBRI (-0.88%) declined. Consumer names were mixed as KLBF (+0.26%) and KAEF (+1.8%) advanced, while MYOR (-0.41%), GGRM (-0.62%), and UNVR (-0.52%) down. Poultry stocks were mixed as CPIN (+4.33%) and JPFA (+4.3%) in green, while MAIN unchanged. Pulp & paper names were positive as INKP (+3.1%) and TKIM (+1.5%) all rose. Other movers were STTP (+11.21%), MDKA (+6.69%), ESSA (-9.92%), and INDY (-7.71%).

The ministry of Energy and Natural resources (ESDM) has implemented a tariff for EV charging stations, under the decision of ESDM no.182.K/TL.04/MEM.S/2023 on fees for electric charging station. For fast charging fees at most Rp25k and for ultrafast charging at most Rp57k, excluding value added tax (PPN)


CAUTIOUS TRADING

The 10Y benchmarks series remained as market's favorite. Overall tone remains cautious and the yield of benchmark series closed the day at 5.95%6.24%6.41%6.48%


