DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

STRENGTHENING

JCI advanced and closed at 6,726 (+100 points or +1.5%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net inflow of IDR 973Bn today and rupiah was stabilized at IDR 14,338/USD.

Banking stocks were mostly positive as BBCA (+2.25%), BBRI (+0.97%), BMRI (+1.74%), and BBNI (+0.35%) all rose, except MEGA (-0.75%). Consumer names were positive as UNVR (+1.22%), ICBP (+1.76%), INDF (+1.97%), GGRM (+1.44%), and KAEF (+4.83%) all advanced. Infra stocks were positive as TOWR (+3.86%), TBIG (+1.67%), JSMR (+4.32%), and PGAS (+2.68%) all inched higher. Material names were positive as BRPT (+4.17%) and TPIA (+2.22%) all in green. Other movers were GEMS (+19.77%), BBHI (+10.41%), PLIN (-6.82%), and BULL (-6.7%).

The gov't has set a policy of one cooking oil price with a price equivalent to Rp14k/litre for all packages. However, this has not been applied to bulk cooking oil sold in traditional markets. For this reason, bulk cooking oil will adjust to the price of packaged cooking oil.


QUIET MARKET

Indonesia bond market closed the week with quiet tone after BI rate meeting yesterday. Only few trades were seen throughout the day with light trading volume especially in the front end. Although the overall market tone was mixed, no significant price action took place. IDR bond the prices ended the day unchanged from yesterday level. The yield of 5/10/15/20Y benchmark closed the week at mid-yield of 5.22%/6.42%/6.41%/6.97% respectively.


