DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

RETREATED

JCI weakened and closed at 5,938 (-37 points or -0.63%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net outflow of IDR 60Bn today and rupiah was stabilized at IDR 14,198/USD.

Banking stocks were mostly negative as PNBN (-1.1%), BBNI (-0.9%), BMRI (-1.26%), and BBRI (-1.48%) all closed lower, except BBCA (+0.93%). Consumer names were mostly negative as ICBP (-0.87%), KLBF (-1.7%), MYOR (-3.05%), and UNVR (-1.32%) all closed lower, except HMSP (+0.39%). Construction stocks were negative as PTPP (-1.94%), WIKA (-1.37%), ADHI (-5.06%), and WSKT (-2.26%) all closed lower. Material names were mixed as TPIA (-4.12%) retreated, while BRPT unchanged. Other movers were ISSP (+15%), HRUM (+12.39%), EMTK (-3.98%), and JPFA (-3.83%).

FLAT TRADING DAY




