DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Slide lower

JCI slightly weakened and closed at 6,928 (-12 points or -0.17%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 1570Tn today and rupiah was stabilized at IDR 15,730/USD.

Banking stocks were negative as BDMN (-1.1%), BBTN (-0.81%), BBNI (-1.44%), BBCA (-1.12%), and BMRI (-2.5%) all closed lower. Consumer names were negative as HMSP (-2.87%), INDF (-0.73%), GGRM (-3.19%), KLBF (-1.1%), and ICBP (-2.52%) all down. Telco stocks were negative as EXCL (-3.36%), ISAT (-3.45%), and TLKM (-1.06%) all corrected. Mining names were mostly positive as ADRO (+2.53%), ANTM (+2.21%), INCO (+1.77%), and ITMG (+1%) all inched higher, except TINS (-5.06%). Other movers were WIIM (+8.47%), BFIN (+4.57%), DOID (-21.87%), and ARTO (-6.52%)

Bank Indonesia's survey for new loan disbursement (SBT) for September 2023 indicated healthy growth with overall SBT of 92.6% higher compared than in August at 86.2%. In terms of corporate credits, SBT is still healthy at 16.1% is higher than previous month's at 14.7%. Overall, loan is anticipated to still grow healthily for the upcoming months.

BOND MARKET


Softer

The bond market opened the day on a weak tone following lackluster auction and higher UST yield overnight. It was overall a quiet market with some activities seen in the short to belly tenor and buying flows in the long end tenor. Weakness in bond was in line with that in USD/IDR as the pair closed higher at 15,725/735. In the meantime, market awaits for BI rate announcement scheduled to be released tomorrow. The benchmark series of 5/10/15/20Y closed the day at mid yield 6.68%/6.86%/7.09%/7.11%.


