DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

CORRECTED

JCI weakened and closed at 6,291 (-86 points or -1.35%) today. Shares across regional markets were negative. Meanwhile, foreign investors recorded net outflow of IDR 18Bn today and rupiah slightly weakened to IDR 14,267/USD.

Banking stocks were negative as MEGA (-1.72%), PNBN (-4.55%), BMRI (-0.76%), BBRI (-1.86%), and BBCA (-4%) all down. Consumer names were mostly negative as INDF (-1.59%), KAEF (-5.41%), ICBP (-1.43%), and UNVR (-2.18%) all closed lower, except HMSP (+4.27%). Mining stocks were mostly negative as ITMG (-0.21%), TINS (-6.9%), INCO (-6.75%), and ANTM (-6.67%) all retreated, except ADRO (+2.95%). Infra names were negative as JSMR (-1.45%), TBIG (-1.38%), PGAS (-2.73%), and TOWR (-4.35%) all weakened. Other movers were DWGL (+34.23%), BOLT (+25%), MIKA (-4.78%), and BRPT (-3.76%).

QUIET MARKET




