# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

### **HIGHER CLOSE**

JCI advanced and closed at 6,047 (+68 points or +1.13%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 555Bn today and rupiah was stabilized at IDR 14,483/USD.

Banking stocks were mostly positive as BBCA (+2.09%), BBRI (+2.7%), BMRI (+3.07%), and BBNI (+3.06%) all inched higher, except MEGA (-1.27%). Consumer names were mostly positive as UNVR (+0.98%), MYOR (+1.29%), INDF (+0.75%), and GGRM (+0.49%) all inched higher, except KAEF (-2%). Telco stocks were positive as TLKM (+2.29%), FREN (+9.26%), and ISAT (+0.41%) all inched higher. Material names were negative as BRPT (-1.83%) and TPIA (-1.02%) all corrected. Other movers were POLL (+17.24%), ARTO (+3.78%), BBHI (-7%), and BSIM (-6.95%).

The State Equity Participation (PMN) to SOEs amounting to Rp33.9tn in 2H21 and Rp72.45tn in 2022 requested by the Ministry of SOE has been approved by the Commission VI of the House of Representatives (DPR). In detail, 2H21 PMN to be injected to Hutama Karya (Rp19tn), Kereta Api Indonesia (Rp7tn), and Waskita Karya (Rp7.9tn).

## **BOND MARKET**


#### **EXTENDED BUYING**

The bond market advanced further today on the back of solid interest from both local and foreign banks players. Buying boosted prices level across the board. Overall sentiment was biddish mainly on front to belly. However, bond prices movement was quickly capped by profit takers. Overall, bonds yield shifted lower by 3-7 bps. In the middle of the day, Indonesia June trade balance date came out today and printed a surplus of +USD\$1.3Bio. The benchmark of 10Y FR87/11Y FR91 traded to as high as 101 (6.35%)/100.3 (6.33%).


