DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

SLIGHTLY UP

JCI slightly strengthened and closed at 6,658 (+11 points or +0.17%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 588Bn today and rupiah slightly strengthened to IDR 14,295/USD.

Banking stocks were mixed as BBRI (+0.72%) rose, BBTN (-0.29%), BBNI (-0.35%), and BMRI (-0.35%) down, and BBCA unchanged. Consumer names were mixed as MYOR (+1.89%), ICBP (+0.29%), and GGRM (+0.23%) up, while SIDO (-1.58%) and UNVR (-1.39%) retreated. Infra stocks were positive as TBIG (+4.63%), PGAS (+3.08%), TOWR (+0.95%), and JSMR (+0.27%) all in green. Telco names were positive as TLKM (+1.7%), FREN (+9.2%), and EXCL (+2.37%) all closed higher. Other movers were MSIN (+9.69%), INCO (+8.68%), EMTK (-6.98%), and BSSR (-6.84%).

OJK recorded that the net profit of the banking industry until October 2021 reached Rp.118tn, an increase of 27.64% YoY which was Rp.92.64tn. Profit achievement from NIM was Rp355.44tn or grew by 13.43% YoY. Then, non-operating income was Rp15.95tn with operating expenses up 9.55% YoY to Rp591.63tn.

BOND MARKET


SLOW DAY

Bond market opened the day softer and wider as bidders were in defensive mode after US CPI data came out as the market expected. Some biddish tone from local banks and interbank were seen on the bid side, especially on 5Y - 10Y tenor and small activity in long tenor. Overall market was relatively quiet with small trades on benchmark series. By the end of day yield curve closed slightly lower by 2 - 3 bps.


