INDONESIA MARKET WRAP

EQUITY MARKET

SLIGHT REBOUND

JCI slightly strengthened and closed at 6,839 (+29 points or +0.43%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net inflow of IDR 20Bn today and rupiah was stabilized at IDR 15,190/USD.

Banking stocks were mostly positive as BBRI (+0.84%), BBKA (+0.58%), BMRI (+0.75%), and BBNI (+1.13%) all advanced, except MEGA (-0.88%). Consumer names were mostly negative as HMSP (-0.88%), INDF (-0.38%), GGRM (-2.5%), and UNVR (-1.79%) all down, except KLBF (+0.93%). Properties stocks were positive as PWON (+3.13%), SMRA (+3.51%), LPKR (+5.19%), and CTRA (+1.6%) all advanced. Material names were positive as BRPT (+3.3%) and TPIA (+0.43%) all closed higher. Other movers were BFIN (+3.08%), TLKM (+2.85%), MDKA (-6.72%), and ARTO (-5.8%).

Bank Indonesia Governor Perry Warjiyo has been nominated for another five-year term in a move that should solidify monetary policy continuity in Southeast Asia's largest economy.

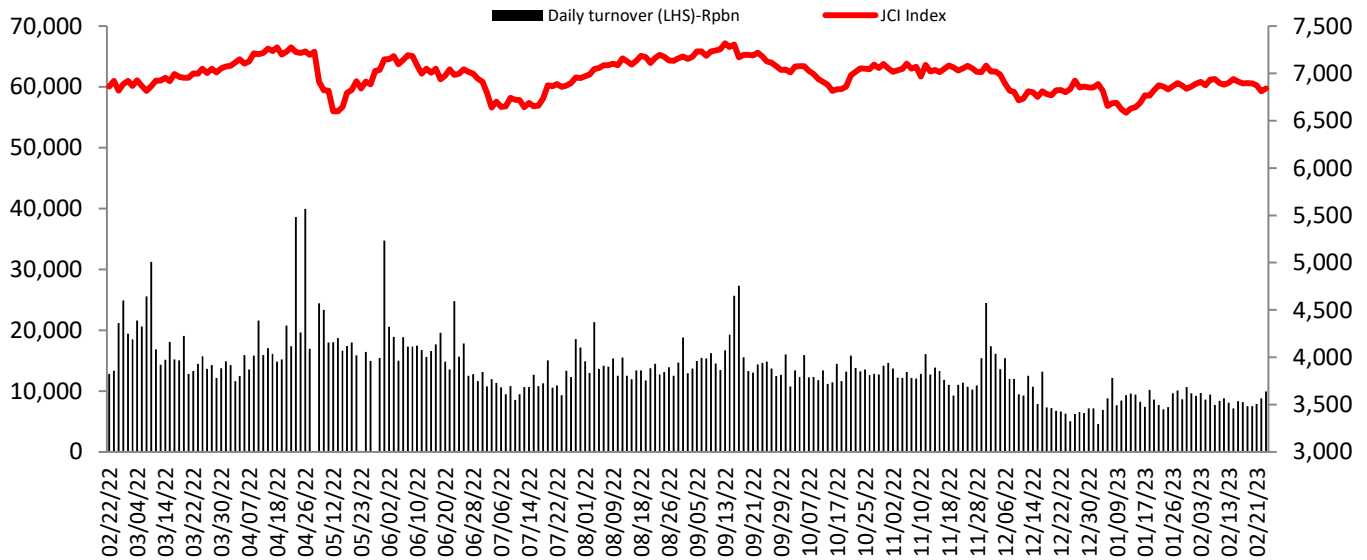
BOND MARKET

LITTLE CHANGE

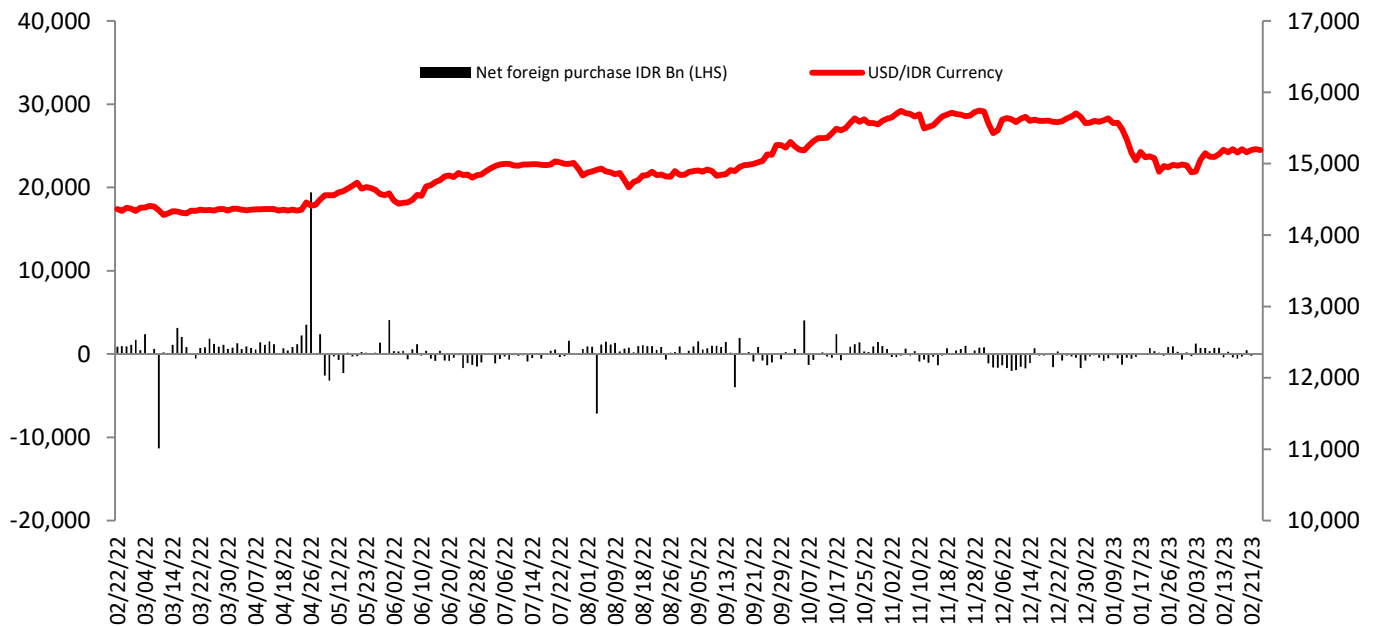
Indonesia bond market closed the day in softer tone. Limited activities was focus on 15Y and 20Y area while the other part of the yield curve was quoted within range throughout the day. There is not much activity both from local and foreign as market awaits for US GDP data and FOMC meeting minutes. By the end of day yield curve of 15Y and 20Y closed slightly higher by 3 – 5 bps, while the other curve remained unchanged.
