DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Further Rebound

JCI advanced and closed at 7,212 (+83 points or +1.16%) today. Shares across regional markets were positive. Meanwhile, foreign investors recorded net inflow of IDR 341Bn today and rupiah advanced to IDR 16,035/USD.

Banking stocks were mostly positive as BMRI (+2.26%), BBCA (+1%), BBRI (+0.43%), and MEGA (+2%) all advanced, except BBNI (-0.5%). Consumer names were positive as SIDO (+2.9%), HMSP (+2.31%), ICBP (+0.45%), UNVR (+0.81%), and INDF (+0.41%) all rose. Material stocks were positive as TPIA (+6.46%) and BRPT (+2.96%) all closed higher. Poultry names were positive as CPIN (+3.92%), JPFA (+2.48%), and MAIN (+4.24%) all inched higher. Other movers were KPIG (+11.86%), INKP (+3.8%), YULE (-5.2%), and BOGA (-3.41%).

The Coordinating Minister for Maritime Affairs and Investment said the president-elect plans to announce the composition of his cabinet on 21 October 2024, or the day after his inauguration.

BOND MARKET


TWO WAY INTEREST

The mixed sentiment was seen in the bond market today with the bond price opened around the same level as yesterday's closing. Market saw mixed flow during the day as investor interest focused on belly series. Prices moved in tight range with overall biddish market tone was dominated by onshore names while offshore names tried to book profit. The 5Y/10Y yield lower by about 1 – 2 bps compared to yesterday closing, while the rest of the curved unchanged.


