DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Lower

JCI slightly weakened and closed at 6,901 (-15 points or -0.21%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net outflow of IDR -1.34Tn today and rupiah slightly strengthened to IDR 15,283/USD.

Banking stocks were mixed as MEGA (+0.49%) inched higher, BNLI (-0.52%), BDMN (-0.33%), and BBRI (-0.9%) corrected, and BBCA unchanged. Consumer names were positive as ICBP (+1.74%), INDF (+1.43%), KLBF (+1.08%), GGRM (+2.52%), and HMSP (+1.69%) all inched higher. Pulp & paper stocks were negative as TKIM (-2.16%) and INKP (-3.23%) all down. Telco names were positive as TLKM (+0.26%), EXCL (+3.07%), and ISAT (+1.56%) all advanced. Other movers were BBHI (+5.56%), ARTO (+2.33%), STTP (-7.5%), and SMSM (-4.11%).

Indonesia's trade balance surplus as of July 2023 dropped to USD1.31b from USD3.45b in June 2023. The surplus was attributed to non-oil and gas trades that booked at USD3.22b with total export worth at USD19.65b.

BOND MARKET


TWO WAY INTEREST

The mixed sentiment was seen in the bond market today with the bond price opened around the same level as yesterday's closing. Market saw mixed flow during the day as investor interest focused on belly series. Prices moved in tight range with overall biddish market tone was dominated by onshore names while offshore names tried to book profit. The 5Y/10Y yield higher by about 3 – 5bps compared to yesterday closing, while the rest of the curved moved up by 2 - 4 bps. Tomorrow INDOGBs market will be closed due to independence day holiday.


